The following items are in response to the 2<sup>nd</sup> data request letter from the PSC dated December 21, 2016.

- 1. Meter Replacement : We only obtained the one bid for meter replacement that has been previously submitted. The reason we had only one bid was because the company we received the bid from is the same company that we recently used to purchase new water meters at one of our other utilities. They also sold us the meter reading equipment that is used for automatic direct reading of the meters we purchased. Thus, the meter reading equipment we have already purchased will be able to be used to read the new meters we install at Four Lakes.
- 2. Meter Testing & Records : We currently do not have in our possession meter testing records. The last operator took much of our paperwork with him when he left our company and this was included. However, meters have been tested as required. We have hired a new water operator and going forward all meter tests will be recorded and kept as required. We do in fact know that on May 5, 2016 two of our employees (Lew Gaskins and Harold Cox) checked a number of residential meters. The list of residential meters they checked are all listed on a report that is included (this report is titled Billing Exception Report which is a report of all meter readings that showed zero water usage for that quarter of billing). The customer number on the report indicates the lot number of the

residential meter. These meters were all tested and determined to be bad (not reading at all).

- 3. Inactive Service Connections : There are no inactive service connections.
- 4. Salaries & Wages Employees : No additional employees were hired during this time. Salaries and wages increased during this time period at Four Lakes because we re-allocated salaries of our existing employees after we discovered their salaries were not properly allocated.
- 5. Water Pumped, Purchased and Sold : The completed table is included. Some items of note on the table: 1) I added August 2015 to the Finished Water from Wells column as the billing in Nov 2015 was for the prior 3 months (Aug, Sept, and Oct). This adjustment properly reflects the water pumped toward the water billed for. This also gives us 12 months of matching pumped vs. billed figures. 2) In May 2016 the master meter was replaced at the well. So that day the meter was replaced the reading was not accurate. I took the average daily pumped figure for the month and used it for that day.
- 6. General Service Customers : List is included
- 7. General Service Rates : General service rates are the same as residential service rates (Monthly base water/sewer charge of \$26.18, consumption rate of \$0.00 up to 5,000 gallons/month and \$1.05 per 1,000 gallons over the 5,000 /month allowance.
- 8. Water Only or Wastewater Only Service Rates : If a customer only has one service, we charge half of the monthly base facility charge and half of the consumption charge.
- 9. Misc. Services :
  - a. We have on average approximately 43 residents delinquent on paying each billing cycle
  - b. No new customers connected to the utility for service
  - c. We did not disconnect any service during this time period
