

I received your e-mail stating that Comcast needed to update the names contained on its certificates with the Florida Public Service Commission and that you can update those names upon our request. Accordingly, please see below:

The entity name "Comcast Phone of Florida, LLC d/b/a Comcast Digital Phone d/b/a CIMCO, a Division of Comcast Business Services" should be changed to: "Comcast Phone of Florida, LLC d/b/a Comcast Digital Phone". That entity, Comcast Phone of Florida, LLC is active and registered with the Florida Department of State, document number M0100000499.

The entity name "Comcast Business Communications, LLC d/b/a Comcast Long Distance" should be changed to simply "Comcast Business Communications, LLC". That entity also is still active, with document number M0600000506.

Dear Mr. David Konuch

Requirements to hold a Certificate of Authority to provide telecommunications service in the state of Florida include keeping the status of your corporate and fictitious (d/b/a) name(s) active with the Florida Department of State, Division of Corporations, per Section 364.335(2), Florida Statutes:

The commission shall grant a certificate of authority to provide telecommunications service upon a showing that the applicant has sufficient technical, financial, and managerial capability to provide such service in the geographic area proposed to be served. **The applicant shall ensure continued compliance with applicable business formation, registration, and taxation provisions of law.** (Emphasis added)
