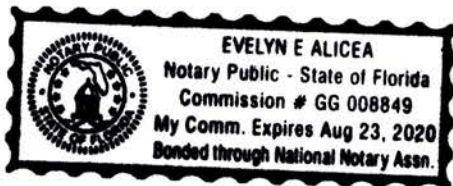

By Order No. PSC-17-0042-PAA-WU, in Docket No. 140175-WU, issued February 1, 2017, the Florida Public Service Commission (Commission) approved a phase II increase in water rates for Crestridge Utilities, LLC. (utility). A schedule of Commission approved rates are set forth below.

The rates shall be effective for service rendered as of the Commission's stamped approval date on the tariff sheets provided the customers have received notice. If the effective date of the new rates falls within a regular billing cycle, the initial bills at the new rate may be prorated. The old charges shall be prorated based on the number of days in the billing cycle before the effective date of the new rates. The new charges shall be prorated based on the number of days in the billing cycle on or after the effective date of the new rates.
