#### AT&T FLORIDA'S RESPONSES TO STAFF'S FIRST DATA REQUEST

BellSouth Telecommunications, LLC d/b/a AT&T Florida hereby submits its

responses to Staff's first set of data requests.

REQUEST: In its proceeding in Tennessee, did AT&T state in writing to the Tennessee Regulatory Authority that AT&T would continue to provide "universal service" in its proposed relinquishment area in Tennessee? If so, please provide the document and cite the location in the document making this claim.

**RESPONSE**:

The only documents AT&T Tennessee filed in its ETC relinquishment proceeding before the Tennessee Regulatory Authority were its Verified Petition (and exhibits), and, later, revised exhibits. The Verified Petition referred to "universal service" in paragraphs 3, 6, and 10, generally to explain how universal service funding has worked in the past and how the FCC's change to universal service funding was one of the reasons for AT&T Tennessee's ETC relinquishment. Also, like the AT&T ILECs' ETC relinquishment requests in other states, the Verified Petition in Tennessee contained a footnote 9 on page 5, which stated that "AT&T will not discontinue *any* service as a result of the Authority granting this Petition."

- REQUEST: On page 10, footnote 15 of its Petition in this docket, AT&T Florida states that certain requirements of 47 U.S.C. § 214(e)(4) are "inapplicable to this Petition because, as noted in Section III.C, AT&T will not discontinue *any* service as a result of the Commission granting this Petition."
  - a. Does AT&T Florida claim that it will continue to provide "universal service" as the term is used in 47 U.S.C. § 214(e)(4) and 47 C.F.R. § 54.205 in its proposed relinquishment areas? Please explain your answer.

#### **RESPONSE:**

As stated in paragraphs 6, 7, and 20 of AT&T Florida's Petition, AT&T Florida is not discontinuing *any* service by virtue of its Petition here. Rather, AT&T Florida will continue to offer and provide retail legacy voice service across its entire service territory (including in the relinquishment area) at its standard rates (including applicable surcharges, fees, and taxes). AT&T Florida also will continue to comply with applicable service obligations of federal and state law across its entire service territory (including in the relinquishment area), unless and until it separately obtains any necessary permission to stop providing retail legacy voice service. Petition, ¶¶ 6, 20. The only consumer impact of relinquishment is that Lifeline-eligible consumers in the relinquishment area will no longer receive a Lifeline discount on voice service from AT&T Florida.

Question 2(a) refers to the term "universal service" in 47 U.S.C. § 214(e)(4)

and 47 C.F.R. § 54.205(b). Generally speaking, the term "universal service" refers not to a specific service, but rather to the goal that all Americans should have access to communications services and to the programs, policies, and funding mechanisms used to support that goal. https://www.fcc.gov/general/universal-service; see generally 47 U.S.C. § 254. As an ETC, AT&T Florida has been eligible to receive federal universal service funding in accordance with 47 U.S.C. § 254, in exchange for which it has been required to offer and advertise supported services pursuant to 47 C.F.R. § 54.201(d) and meet the obligations associated with the universal service programs in which it participates. See 47 U.S.C. § 214(e)(1). As a result of regulatory changes, however, AT&T Florida no longer receives federal high cost funding for the relinquishment area. Petition, ¶ 11-13. That change, along with marketplace changes, led to AT&T Florida's Petition. The granting of the Petition will relieve AT&T Florida of the obligations associated with being an ETC in the relinquishment area. AT&T Florida's relinquishment will not affect the ability of other ETCs to participate in the federal universal service program, including Lifeline, or the amount of universal service support available in Florida.

The specific concern in the portion of Section 214(e)(4) and FCC Rule 54.205(b) referenced in question 2(a) is with "ensur[ing] that all customers served by the relinquishing carrier will continue to be served" after a carrier relinquishes its ETC

status for an area. As stated in footnote 15 of the Petition, that concern does not exist in this proceeding, so the cited language is inapplicable. Unlike a carrier that relinquishes its ETC status and goes out of business or exits an area entirely, AT&T Florida will not discontinue *any* service in the relinquishment area as a result of its Petition. Petition, ¶¶ 6, 7, 20. Accordingly, *no customer will be left without service as a result of AT&T Florida's ETC relinquishment*. Likewise, no competitive ETC will need to take any action – much less build any facilities – to ensure that customers in the relinquishment area continue to have access to service. AT&T Florida will continue to serve the same customers it serves today unless and until they switch to another provider.

Customers in the relinquishment area that choose to switch carriers will have many options. Competing carriers in Florida have had no problem serving the vast majority of the state's voice service customers. In fact, from 2009 through the end of 2016, AT&T Florida's retail residential voice lines declined by about 95% as customers flocked to other providers. Petition, ¶ 15. There also is no issue regarding the ability of eligible customers in the relinquishment area to keep receiving voice service with a Lifeline discount. In recent years Lifeline customers have expressed their preference by switching to ETCs other than AT&T Florida in large numbers. Competing ETCs now serve hundreds of thousands of Lifeline customers, more than 99% of the statewide

total, while AT&T Florida serves less than one percent of Lifeline customers. Petition, ¶ 25 & Ex. C. Moreover, every wire center in the relinquishment area is served by at least seven ETCs other than AT&T Florida. There is no doubt that competing carriers and competing ETCs in the relinquishment area are ready and able – and presumably eager – to serve any and all Lifeline customers who elect to leave AT&T Florida after relinquishment.

Finally, it bears noting that if AT&T Florida ever did seek to discontinue providing retail legacy voice service in the relinquishment area, federal safeguards would come into play. Specifically, AT&T Florida could not stop providing basic legacy residential voice service unless and until it filed a petition with the FCC under 47 U.S.C. § 214(a).<sup>1</sup> AT&T Florida would then have to demonstrate to the FCC that "neither the present nor future public convenience and necessity will be adversely affected" by discontinuing service.

To determine whether a proposed discontinuance would adversely affect the public interest, the FCC employs a five-factor balancing test that analyzes: (1) the

financial impact on the common carrier of continuing to provide the service; (2) the need for the service in general; (3) the need for the particular facilities in question; (4) increased charges for alternative services; and (5) the existence, availability, and adequacy of alternatives.<sup>2</sup> And in the *2016 Technology Transitions Order*, the FCC concluded that the existence, availability, and adequacy of alternatives (fifth factor) has heightened importance in the context of technology transitions.<sup>3</sup> The FCC also is expressly authorized to impose conditions on the approval of any discontinuance request that "in its judgment the public convenience and necessity require." 47 U.S.C. § 214(c).

State commissions play a vital role in any Section 214(a) discontinuance request. The FCC's rules ensure that the affected state is provided notice and has the opportunity to participate in any Section 214(a) proceeding involving a discontinuance of basic residential voice service. Specifically, Section 63.71(a) of the FCC's rules

requires AT&T Florida to send a copy of any Section 214(a) application seeking discontinuance to the Governor of Florida, and the State then has a "right . . . to be heard" on all issues and concerns in that proceeding. 47 U.S.C. § 214(b). Moreover, Congress authorizes a state commission to seek an injunction in "any court of competent jurisdiction" if it believes FCC approval of a discontinuance request is not in the public interest. 47 U.S.C. § 214(c). Thus, as a practical matter, the FCC would not be able to approve any AT&T Florida request to discontinue basic residential voice service anywhere in Florida without notifying the Commission and providing the Commission with an opportunity to submit comments on whether such discontinuance could occur without harm to the public interest. And if the Commission disagrees with the FCC's conclusions, it has a statutory right to challenge the FCC in court.

b. If the answer to question 2.a. above is "yes," why did AT&T Florida file a petition pursuant to 47 C.F.R. § 214(e)(4), "Relinquishment of universal service"?

**RESPONSE:** 

AT&T Florida filed its Petition pursuant to 47 U.S.C. § 214(e)(4) and 47 U.S.C. § 54.205 because those are the provisions that give any ETC the right to "relinquish its designation as such a carrier in any area served by more than one [ETC]," and establish that state commissions "shall permit" such relinquishment. This Commission has allowed carriers to relinquish their ETC status under those provisions, just as other state commissions have granted AT&T ILECs' petitions to relinquish their ETC status. Petition, ¶ 21-22 & nn.16-17. In addition to the orders cited in the Petition, on April 17, 2017, the Mississippi PSC issued the attached order (Attachment 1) confirming AT&T Mississippi's ETC relinquishment, and on May 3, 2017, the South Carolina PSC issued the attached summary order (Attachment 2) approving AT&T South Carolina's ETC relinquishment. As noted in the response to question 2(a), AT&T Florida's Petition will not result in AT&T Florida discontinuing any service to any customer, but it will result in AT&T Florida being relieved of the obligations of an ETC in the relinquishment area, where it no longer receives any high cost universal service funding. Petition, ¶ 13.

#### **RESPONSE**:

The term "universal service" refers not to a specific service, but rather to the goal that all American should have access to communications services and to the support that goal. and funding mechanisms used to programs, policies, https://www.fcc.gov/general/universal-service; see generally 47 U.S.C. § 254. As explained above in response to question 2(a) and in the Petition, granting AT&T Florida's relinquishment of ETC status will not result in AT&T Florida discontinuing any legacy voice service to customers in the relinquishment area, will not remove AT&T Florida's federal common-carrier obligations to provide voice service upon reasonable request on just and reasonable terms and on a nondiscriminatory basis, and AT&T Florida could not discontinue service in the relinquishment area without obtaining all necessary regulatory approvals. AT&T Florida simply would no longer serve as an ETC or provide a Lifeline discount in that area. Customers in the relinquishment area that desire to keep a Lifeline discount on their voice service will have at least seven other ETCs to choose from and will receive advance notice of AT&T Florida's relinquishment. Petition, ¶¶ 25-28 & Ex.

REQUEST: Please refer to page seven of Exhibit C to AT&T's Petition in this docket (CETC's Designated in AT&T Florida's Current ETC Service Area). For each CETC listed, please designate whether the CETC interconnects with AT&T Florida via UNEs, resale, both, or another arrangement (please describe).

#### **RESPONSE**:

The list of CETCs in Exhibit C includes facilities-based competitive local exchange carriers ("CLECs"), facilities-based Commercial Mobile Radio Service ("CMRS") Providers, and firms that resell the services of facilities-based carriers. AT&T Florida, as an ILEC under § 251(h) of the federal Telecommunications Act of 1996 ("1996 Act"), interconnects and exchanges traffic with facilities-based CLECs and CMRS providers pursuant to Commission-approved interconnection agreements ("ICAs") pursuant to Sections 251-252 of the 1996 Act. AT&T Florida's ICAs provide CLECs the opportunity to purchase unbundled network elements ("UNEs") and to resell AT&T Florida's telecommunications services at the Commission-approved wholesale resale discount. CMRS providers, per FCC rules, are not entitled to purchase UNEs.

Additionally, AT&T Florida notes that the FCC updated its rules to eliminate ILECs' obligation to resell Lifeline and/or Link-Up discounted retail offerings at the

wholesale resale discount under § 251(c)(4) of the 1996 Act. *In the Matter of Lifeline and Link Up Reform and Modernization*, 30 FCC Rcd. 7818 (rel. June 22, 2015). The FCC also eliminated any reimbursement to AT&T Florida for any resold Lifeline and/or Link-Up services. This change was effective on August 15, 2016, and AT&T Florida provided notice to all CLECs. After August 15, 2016, CLECs could choose to resell AT&T Florida's access lines and to seek reimbursement for the Lifeline discount themselves after receiving ETC status.

### ORDER CONFIRMING AT&T MISSISSIPPI'S RELINQUISHMENT OF ITS ELIGIBLE TELECOMMUNICATIONS CARRIER DESIGNATION IN SPECIFIED AREAS

This matter came before the Mississippi Public Service Commission ("Commission" or "MPSC") for consideration of the Verified Petition of AT&T Mississippi for an Order Confirming Relinquishment of Its Eligible Telecommunications Carrier Designation in Specified Areas ("Petition") filed by AT&T Mississippi<sup>1</sup> ("AT&T" or "Company").

On October 28, 2016, AT&T filed its Petition to relinquish its ETC designation for a portion of its service area in the State of Mississippi. AT&T is currently designated as an eligible telecommunications carrier ("ETC") in the wire centers listed in Exhibit A to AT&T's Petition, which are also depicted on the map attached as Exhibit A to the Commission's order designating service areas in Docket No. 1997-AD-0552.<sup>2</sup> AT&T seeks to relinquish its ETC designation where the Company is not eligible for high-cost universal service support, which is the entirety of its service area except for the area identified in Exhibit B to AT&T's Petition. Exhibit B to AT&T's Petition identifies the census blocks<sup>3</sup> where the Company remains eligible for high-cost support and therefore plans to retain its ETC designation, including Connect America Fund Phase

II ("CAF II") eligible census blocks and CAF II extremely high-cost census blocks.<sup>4</sup> AT&T's Petition represents that the Company will file a new request for ETC designation if the Company participates in the FCC's CAF II reverse auction and is awarded additional extremely high-cost service areas through that competitive bidding process.<sup>5</sup> AT&T requests a July 5, 2017, effective date of relinquishment, to follow the final installment of the Company's CAF Phase I Incremental Support.

The Commission, being fully apprised in the premises, and having considered the record before it, as authorized by law and upon the recommendation of the Mississippi Public Utilities Staff ("Staff"), finds as follows:

AT&T is an incumbent local exchange company and defined as a price cap company serving rural and urban areas in Mississippi. The Company obtained its ETC designation in 1997 in Docket No. 1997-AD-0552. AT&T's relinquishment of its ETC designation in specified areas in Mississippi is prompted by changes to the universal service program made by the Federal Communications Commission ("FCC"), revising the approach to disbursing high-cost universal service support. Under the new approach, established in the FCC's CAF II, AT&T will receive funding to support and deploy broadband-capable networks in FCC-identified high-cost census blocks in its service area.

The basis for allowing relinquishment of those census blocks where AT&T is not receiving high-cost support is set forth in 47 U.S.C §214(e)(2) and (4) and 47 C.F.R. §54.205.

Section 214(e)(4) states that:

A State Commission . . . shall permit an eligible telecommunications carrier to relinquish its designation as such a carrier in any area served by more than one eligible telecommunications carrier. An eligible telecommunications carrier that seeks to relinquish its eligible telecommunications carrier designation for an area served by more than one eligible telecommunications carrier shall give advance notice to the State Commission . . . of such relinquishment. Prior to permitting a telecommunications carrier designated as an eligible telecommunications carrier to cease providing universal service in an area served by more than one eligible telecommunications carrier, the State commission . . . shall require the remaining eligible telecommunications carrier or carriers to ensure that all customers served by the relinquishing carrier will continue to be served, and shall require sufficient notice to permit the purchase or construction of adequate facilities by any remaining eligible telecommunications carrier. The State commission . . . shall establish a time, not to exceed one year after the State commission . . . approves such relinquishment under this paragraph, within which such purchase or construction shall be completed.

47 U.S.C §214(e)(4).

Exhibit C to AT&T's Petition lists ETCs that are designated in the areas to be relinquished by AT&T, and identifies at least eight other ETCs in each wire center in the relinquishment area. Although many of the ETCs identified are wireless and prepaid low-income wireless providers, rather than wireline facilities-based providers such as AT&T, the FCC is moving away from telephony and towards broadband Internet access service,<sup>6</sup> favoring a change in customers' use of technology over policies that promote the retention of wireline services. In addition, pursuant to Section 47 C.F.R 54.403(a)(2)(iv), standalone voice service, or voice services not bundled with broadband which meets the minimum standard set forth in §54.408, will not be eligible for Lifeline support after December 1, 2021, unless the FCC has previously determined otherwise.

Prior to permitting a telecommunications provider to cease universal service in an area served by more than one ETC, the FCC requires the assurance that all customers served by the relinquishing carrier will continue to be served, and that sufficient notice is provided to the remaining ETC(s) to permit the purchase or construction of adequate facilities.<sup>7</sup> While AT&T must establish that the relinquished area is served by more than one ETC, the requirements related to continuation of service and adequate notice are not applicable in this matter because AT&T will not discontinue any service as a result of the Commission confirming partial relinquishment of the Company's ETC status.<sup>8</sup> The only difference will be that the Lifeline discount will no longer be available for AT&T services in the relinquished areas, however, other ETCs serving those areas may provide the discount should a customer wish to seek it through another service provider.

According to AT&T, as of December 31, 2016, the Company served 1,582 Lifeline customers which are delineated by 1,097 customers in its proposed relinquishment area and 485 in its retained area. AT&T's Petition sets forth the method by which the Company's affected Lifeline customers will be provided notice that they may keep their AT&T service but will no longer receive the Lifeline benefit, or that they may change to another ETC provider.

ETC designation requires that a carrier provide essential telecommunications services, as defined by the FCC in 47 C.F.R. §54.101 and §54.201, and must provide service to all requesting customers, advertise the availability of that service, and provide Lifeline service to low-income customers. Federal high-cost service support has evolved over time to new forms of support and, as discussed above, from a focus on voice to broadband services.

AT&T has filed similar petitions in six other states, including Alabama, Kansas, Missouri, Oklahoma, Tennessee, and Wisconsin.<sup>9</sup> The petitions have been approved in all states except Kansas, which is still pending.

Staff sought guidance from the FCC and National Association of Regulatory Utility Commissioners ("NARUC"). Staff also contacted the Universal Service Administrative Company to confirm that ETC information provided by census block, rather than by wire center as historically presented, would be accepted and received confirmation that it would.

AT&T's Petition supports federal policy by aligning AT&T's ETC designated area with modern high-cost support rules based on census blocks. AT&T meets the objective test for relinquishing its ETC status throughout the specified areas. Subject to conditions set forth and upon approval by the MPSC, AT&T will remain an ETC in the census blocks listed in Exhibit B of its Petition.

#### IT IS, THEREFORE, ORDERED THAT:

1. AT&T's relinquishment of its ETC designation in all portions of its ETC designated area except those identified in Exhibit "B" to AT&T's Petition is hereby confirmed.

2. AT&T may stop enrolling new Lifeline customers in the area where it is relinquishing its designation following the issuance of this Order.

3. The effective date of relinquishment of AT&T's ETC status in the specified areas is July 5, 2017.

4. AT&T shall provide advance notice of the relinquishment of its ETC designation to affected Lifeline subscribers in the manner set forth in its Petition.

#### **COMMISSION ACTION:**

The Company is participating in the FCC's Connect America Fund II (CAF II) which enables it to bring more broadband to high cost, primarily rural areas in South Carolina. AT&T is retaining its ETC designation in certain census blocks for which it is eligible to receive CAF II funding (CAF II Census Blocks) and, pursuant to its right under federal law, AT&T is relinquishing its ETC designation for all of the remaining areas in which it is currently designated an ETC, and will no longer receive federal Lifeline support. The relinquishment areas are served by at least one other ETC. AT&T will continue to offer and provide legacy voice service in all of its service territory, including the relinquishment areas. The Company will provide ample advance notice to all affected customers that Lifeline Discounts will no longer be provided, and the customers can choose to receive Lifeline discounts from another ETC. At the end of 2016, AT&T was serving less than 1% of the 191,812 Lifeline subscribers in South Carolina. The relinquishment becomes effective on October 12, 2017, and AT&T will stop enrolling customers from the relinquishment areas in the Lifeline program no sooner than August 11, 2017.

In any case, Cox has no facilities in these four or any other such rate centers and therefore can provide no residential service other than within the rate centers we have listed above.

## 1. Please verify that your company is a designated ETC in the service areas that AT&T Florida has identified in Exhibit C.

AT&T Florida, a wireline carrier, identifies its service area by wire centers and exchanges. Exhibit C lists those wire centers and exchanges in which AT&T Florida seeks to relinquish its ETC designation. TracFone Wireless, Inc. ("TracFone") is a Commercial Mobile Radio Service ("CMRS") provider that serves Lifeline customers in Florida by reselling the wireless telecommunications services of T-Mobile and Verizon Wireless. TracFone is designated as an ETC throughout its service area in Florida. As a CMRS reseller, TracFone's Lifeline service area in Florida encompasses T-Mobile and Verizon Wireless's service areas.

TracFone defines its service area by relying on service area maps and coverage information identified by ZIP Code provided by its underlying carriers. TracFone's Lifeline service area map and a list of ZIP Codes where TracFone provides Lifeline service in Florida are attached as Exhibit 1. TracFone's underlying CMRS carriers do not define their service areas by wire centers and exchanges. Therefore, TracFone is not able to directly compare its service area to AT&T Florida's list of wire centers and exchanges. However, TracFone's Lifeline service area includes virtually all of Florida (as indicated by TracFone's service area map) and there are only four ZIP Codes in Florida that do not fall within TracFone's Lifeline service area.

- 2. Are you currently providing service to customers in all of the identified areas? If no:
  - a. Please identify any wire centers where your company is not currently serving customers.
  - b. Are you capable of providing service in the designated areas where you are not currently providing service? If not, how long would it take for you to prepare to provide service in those areas?

For the reasons described above in the response to Data Request 1, TracFone is not able to identify its service area by wire center. Therefore, TracFone does not know whether it is currently providing Lifeline service to customers in the wire centers listed in Exhibit C. In the event that the Commission determines that there are wire centers listed in Exhibit C where TracFone is not currently serving customers, TracFone would not be capable of expanding its service area to serve any such wire centers because, as a reseller, TracFone's service area is defined by its underlying carriers' service areas. Therefore, it could only expand its service areas if its underlying network providers expanded their service areas.

TracFone advertises its SafeLink Wireless<sup>®</sup> Lifeline service throughout its service area in Florida. 
