On May 10, 2017, Florida Public Utilities Company (FPUC) filed highlighted information in FPUC's Response to Staff's First Request For Production Of Documents (Nos. 1-3), pursuant to a Notice Of Intent to Request Confidential Classification (DN 04773-17).

On May 19, 2017, pursuant to Section 366.093 of the Florida Statutes, and Rule 25-22.006, Florida Administrative Code, FPUC requested confidential classification of highlighted information in FPUC's Response to Staff's First Request For Production Of Documents (Nos. 1-3), (DN 04942-17, and cross-referenced to DN 04773-17). The Request For Confidential Classification was filed on May 19, 2017 (DN 04941-17).

On May 30, 2017, FPUC made a filing to correct and amend a page from the POD Response. FPUC filed a corrected page identified as Bates Label FPU-01-0037 (DN 05095-17). In its cover letter accompanying the correction, the Company requested that the Request For Confidential Classification filed on May 19, 2017 (DN 04941-17), also apply to corrected page.
