Dear Ms. Stauffer:

This letter is to request that the Florida Public Service Commission notify the Universal Service Administrative Company (USAC) and the Federal Communications Commission (FCC) that Windstream Florida, LLC ("Windstream") is eligible to receive federal high cost support in accordance with the above referenced statute and federal rule.

The amount of federal high-cost support that Windstream will receive in 2018 will continue to be used for the services and functionalities outlined in 47 C.F.R. 54-101(a) and as the attached affidavit shows Windstream certifies that it will only use the federal high-cost support it receives for the provision, maintenance and upgrading of facilities and service for which such support is intended.

This state certification for federal support is an annual process. In order to receive federal support beginning January 1 of each year, the Florida Public Service Commission must file its annual certification on or before October 1 of the year before.

Windstream respectfully requests that the Commission notify the FCC prior to October 1 of this year that Windstream is eligible to receive federal high-cost support for 2017

AFFIDAVIT

BEFORE ME, the undersigned authority appeared Tim Loken who deposed and said:

- 1. My name is Tim Loken. I am Windstream Florida, LLC's, ("Windstream" or the "Company") Director of Regulatory Reporting. I am an officer of the Company and am authorized to give this affidavit on behalf of the Company. This affidavit is being given to support the Florida Public Service Commission's certification as contemplated in 47 C.F.R. §54.313 and §54.314.
- Windstream certifies that all federal high-cost and CAF support was used in the proceeding calendar year and will be used in the new calendar year only for the provision, maintenance, and upgrading of facilities and services for which the support is intended.
- 3. Windstream is eligible for and receives Connect America Cost Model (CACM) and Connect America Fund Intercarrier Compensation (ICC). Attachment A represents the support Windstream received for 2016.
- 4. Windstream hereby certifies that it follows appropriate procedures for network outage reporting in accordance with the Federal Outage Reporting Order and State Outage Reporting Requirements. For the period between January 1, 2015 and December 31, 2015, Windstream had <u>3</u> FCC reportable outages. Windstream had <u>0</u> PSC reportable outages.
- Windstream hereby certifies that it had <u>101</u> unfulfilled (voice) requests for service from potential customers.
- 6. Windstream hereby certifies that for the period from January 1, 2015 through December 31, 2015 it had <u>44</u> FCC complaint and <u>4</u> state PSC complaints were received.
- 7. Windstream hereby certifies that it is able to function in emergency situations, offers a tariffed local usage plan and provides equal access to long distance carriers.
