Generic Purchased Gas Adjustment Issues

<u>ISSUE 1</u>: What are the final purchased gas adjustment true-up amounts for the period January 2016 through December 2016?

PGS: \$1,089,984 over-recovery

<u>ISSUE 2</u>: What are the actual/estimated purchased gas adjustment true-up amounts for the period January 2017 through December 2017?

PGS: \$4,594,365 under-recovery

<u>ISSUE 3</u>: What are the total purchased gas adjustment true-up amounts to be collected during the period January 2018 through December 2018?

PGS: \$3,504,381 under-recovery

<u>ISSUE 4</u>: What are the levelized purchased gas cost recovery (cap) factors for the period January 2018 through December 2018?

<u>PGS</u>: \$1.04915 per therm

<u>ISSUE 5</u>: What should be the effective date of the new purchased gas adjustment charge for billing purposes?

<u>PGS</u>: The charge should be effective beginning with the specified purchased gas cost recovery cycle and thereafter for the period January 2018 through December 2018. Billing cycles may start before January 1, 2018, and the last cycle may be read after December 31, 2018, so that each customer is billed for twelve months regardless of when the adjustment charge became effective.
