## FLORIDA CITY GAS PRELIMINARY STATEMENT OF ISSUES AND POSITIONS

Florida City Gas submits this preliminary statement of issues and positions:

Issue 1: What are the final purchased gas adjustment true-up amounts for the

period January 2016 through December 2016?

Florida City Gas: An over-recovery of \$1,617,503.

Issue 2: What are the actual/estimated purchased gas adjustment true-up

amounts for the period January 2017 through December 2017?

Florida City Gas: An under-recovery of \$1,778,891.

Issue 3: What are the total purchased gas adjustment true-up amounts to be

collected during the period January 2018 through December 2018?

Florida City Gas: An under-recovery of \$161,388, for a true-up charge factor of 0.396

cents per therm.

Issue 4: What are the levelized purchased gas cost recovery (cap) factors for

the period January 2018 through December 2018?

Florida City Gas: Based on the winter months of October through March the

appropriate (cap) factors are 72.485 cents per therm before the regulatory assessment fees are added and 72.850 cents per therm

with regulatory assessment fees included.

<u>Issue 5:</u> What should be the effective date of the new purchased gas

adjustment charge for billing purposes?

Florida City Gas: The factors should be effective for all meter readings on or after

January 1, 2018 and should apply for bills rendered for meter readings taken between January 1, 2018 and December 31, 2018.

<u>Issue 6:</u> Should the Commission approve revised tariffs reflecting the new

purchased gas adjustment charges determined to be appropriate in

this proceeding?

Florida City Gas: Yes. The Commission should approve revised tariffs reflecting the

new purchased gas adjustment charges determined to be

appropriate in this proceeding. The Commission should direct staff to verify that the revised tariffs are consistent with the Commission's

decision
