For forecasted periods, the last available actual month-end AA financial 30-day Commercial Paper Rate is used to set the interest rate for all subsequent months. (For example, the July 31, 2017 AA financial Commercial Paper rate of 1.12% was entered on line 6 in July as the interest rate to use for the subsequent month of August).

- **A.** PGS is taking a very proactive approach to removing all pipes that PHMSA has identified as being of concern.


In 2018, the company plans to improve its efforts by securing additional contractors, facilitating:

- a. The acceleration of Cast Iron and Bare Steel pipeline replacement on our system from 49 miles in 2017 to 90 miles in 2018.
 - The company now expects to successfully complete the Cast Iron/Bare Steel replacement program by 2021, a full year earlier than initially envisioned.
 - ii. As a result, the 2018 CIBS costs are expected to be \$8.9 million higher than 2017.
- b. Implementing the first full year for the company's removal efforts for problematic plastic pipe.
 - i. The full year cost is expected to be \$11.76 million, an additional \$7 million over the pilot project costs in 2017.


In addition, the accelerated replacement schedule will result in better accessibility to contactors and supplies. Recent experience has shown that with a slower replacement schedule, it can be difficult to mobilize contractors and manage supplies.

- A. In 2017, Peoples cast iron and bare steel replacement activity has been in Ocala, Sarasota, Jacksonville, Eustis, Orlando, St. Pete, Miami and Tampa, with the larger concentration of replacement in the Tampa and St. Pete areas. See chart below for a summary of location, mileage replaced (actual and estimated) and type of material.

 - b. Does Peoples continue to use DIMP in determining the replacement projects? Please explain your answer.
- A. Yes. The Company's efforts under its replacement program continue to identify and target the replacement need for specific pipeline replacement in the company's more urban and high consequence areas. Peoples utilizes a risk-based prioritization to determine the order of replacement, which are primarily identified by the FERC-required DIMP and other factors including leak incident rates, the pressure under which the pipeline is operating, areas of significant construction and the age of the pipeline.
 - b. Yes. See response to Data Request No.10a.
