**SJNG Answer**: Total therm sales on Sch. E-5 were erroneously including transportation (FTS-4) therm sales. The correct firm therm sales on Sch. E-5 should be 903,753.

<u>2.</u> Please confirm that the transportation therm sales shown on Sch. E-5 are excluded from the PGA calculation (as St. Joe does not purchase gas for transportation customers).
<u>SJNG Answer</u>: SJNG confirms that the transportation therm sales shown on Sch. E-5 were incorrect and should not have been included in the PGA calculation.
