SECTION 63.71 APPLICATION OF TELCOVE OPERATIONS, LLC

TelCove Operations, LLC (FRN: 0003-7091-10) ("Applicant"), a subsidiary of Level 3 Communications, LLC, seeks authorization pursuant to Section 214(a) of the Communications Act of 1934, as amended, 47 U.S.C. § 214(a), and Section 63.71 of the Commission's rules, 47 C.F.R. § 63.71, to discontinue its provision of ISDN/PRI and analog phone services in the North Charleston and Spartanburg, SC and Daytona Beach, FL metropolitan areas.

5. <u>Brief Description of the Dates and Methods of Notice to All Affected</u> <u>Customers</u>: Applicant sent a written notification of the planned discontinuance to customers utilizing the services in accordance with Section 63.71(a) of the Commission's Rules. 6. <u>Whether the Carrier is Considered Dominant or Non-dominant with</u> <u>Respect to the Service to be Discontinued</u>: Applicant is considered non-dominant with respect to the services to be discontinued.
