Pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code, Gulf Power Company (GPC) requests confidential classification of its Kingfisher I Energy Purchase Agreement (Agreement), included as Exhibit "B" of its petition requesting approval of its Waiver and Scheduling Agreement with Morgan Stanley Capital Group, Incorporated.

GPC requests confidentiality of the same highlighted portions of its Agreement which were previously granted confidential classification in Order No. PSC-15-0193-CFO-EI.¹ As previously done, GPC requests confidentiality under Section 366.093(d), F.S.: "[I]nformation concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms," and Section 366.093(3)(e), F.S.: "[I]nformation relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information." Staff has reviewed GPC's confidentiality request pertaining to the Agreement and, seeing as the portions highlighted are the same portions that were previously granted confidential classification, staff recommends that this information meets the criteria for confidential classification pursuant to Section 366.093(3)(d) and (e), F.S.
