Dear Mr. Bernier:

Please provide a response to the following questions regarding the proposed modifications to programs standards for the Low Income Weatherization Assistance Program (LIWAP) and the Neighborhood Energy Saver (NES) Program by December 28, 2017.

- 1. Please refer to Section 3.0 of the LIWAP Program Standards, the row titled "Energy-efficient Light Bulbs."
 - a. Please clarify the meaning of the phrase "similar lumen output."
 - b. Is the intent of this program to only replace incandescent light bulbs and exclude compact fluorescent light bulbs from replacement? If so, please explain. If not, please provide revised pages including modifications reflecting this clarification.
- 2. Refer to Attachment C accompanying the proposed Revisions to Program Standards Low Income Weatherization Assistance Program and Neighborhood Energy Saver Program.
 - a. Attachment C shows a proposed \$2.75 incentive for LED 12 75 Watt equivalent bulbs. However, Section 3.0 of the LIWAP Program Standards shows a "Maximum Incentive Amount" of \$2.50 per lamp. Please clarify what the correct "Maximum Incentive Amount" is. If changes are required, please provide revised pages.
 - b. Why are the "Incentive per Bulb" amounts for LED 10 and LED 12 light bulbs, as shown in Attachment C, not individually reported in Section 3.0 of the LIWAP Program Standards? If you decide to revise these pages, please provide the revised pages.

- 3. Please refer to Section 10.1.2 of the LIWAP Program Standards, the row titled "Light Bulbs".
 - a. The "Participation Requirements" of this weatherization measure read more as the method that will be implemented as opposed to requirements of the measure. Would you agree that replacing "Replace incandescent bulbs with energy-efficient bulbs with similar lumen output operating a minimum of 3 hours per day" with "Operation of incandescent bulbs a minimum of 3 hours per day" would better characterize the "Participation Requirements" of this measure? If so, please provide revised pages. If not, please explain.
- 4. Please refer to Section 5.1 of the NES Program Standards. Explain why the table is being deleted.
