On January 17, 2018 Peninsula filed a request for confidential classification for Document No. 00306-2018. This document contains information in Exhibit A to gas firm transportation service agreement, page 9, with Florida Public Utilities Company (FPUC) identifying maximum daily transportation quantity. Staff reviewed the document and concurs with Peninsula that the nature of the information meets the requirements set forth in Sections 366.093(3) (d) and (e), Florida Statutes (F.S.), whereby disclosure of the information would harm the competitive business operations of FPUC.
