3 MS. JANJIC: Danijela Janjic presenting  
4 Item 13.

5 On November 14, 2017 Seminole Waterworks,  
6 Inc., filed a petition for variance or waiver of  
7 Rule 25-30.120 Florida Administrative Code, which  
8 requires that the regulatory assessment fees be  
9 paid for any year during which a utility is subject  
10 to the Commission's jurisdiction, as of  
11 December 31st of that year.

12 The waiver is sought in connection with the  
13 utility's application for grandfather water  
14 certificate in Leon County and application for  
15 pass-through increase of regulatory assessment  
16 fees.

17 Staff recommends that the Commission approve  
18 the utility's request for waiver or variance until  
19 such time as the utility is authorized to increase  
20 its rates or within three months of the  
21 Commission's vote, whichever occurs first.

22 Staff is available for any questions. And I  
23 believe Troy Rendell is somewhere in the audience  
24 and is present to answer any questions on behalf of  
25 the utility.
