I just wanted to follow up with both of you since I will be out of the office Thursday and Friday.

I'm waiting to hear back from Ellen as to how they would like to receive the petitions. Below are the options we discussed:

The PSC picking up the original hardcopies. CS would retain a scanned copy.

Emailing pdfs to the PSC, probably in groups of 10-20 pdfs per email
