By Order No. PSC-2018-0109-TRF-WS, in Docket No. 20170255-WS, issued February 27, 2018, the Florida Public Service Commission (Commission) approved customer deposits, and miscellaneous service charges for the Utility. The Commission also approved an investigation of meter tampering charge, which may be levied when there is evidence of meter tampering by the customer.
