FLORIDA INDUSTRIAL POWER USERS GROUP'S DIRECTIONS
TO CLERK OF THE FLORIDA PUBLIC SERVICE COMMISSION
AND STATEMENT OF ACTS TO BE REVIEWED

Pursuant to Rule 9.200(a)(3), Florida Rules of Appellate Procedure, the Florida Industrial Power Users Group ("FIPUG"), respectfully directs the Clerk of the Florida Public Service Commission to include in the record on appeal the items set forth below.

Within these Directions, "FPL" refers to Florida Power & Light Company; FIPUG refers to the Florida Industrial Power Users Group, and the "PSC" or "Commission" means the Florida Public Service Commission.

1. As stated in FIPUG's Notice of Administrative Appeal, FIPUG's has appealed Order No. PSC-2018-0028-FOF-EI, dated January 8, 2018, which is the

Final Order Approving Projected Expenditures and True-Up Amounts for Fuel Adjustment Factors; GPIF Targets, Ranges, and Rewards; and Projected Expenditures and True-up Amounts for Capacity Cost Recovery Factor. As discussed in the Statement of Acts to be Reviewed below, FIPUG's appeal involves only those issues related to FPL and its solar based rate adjustment petition. Accordingly, unless otherwise specifically listed below, please exclude from the record on appeal all pleadings, orders, prefiled testimony, transcripts of hearings, exhibits, and all other documents in the docket file of Docket No. 20170001-EI1 that solely relate to and are associated with the petitions filed by other investor-owned utility companies. It is the intent of these Directions to exclude all documents that relate solely to utilities other than FPL, and to include documents that relate only to the solar based rate adjustment issue involving FPL.
