**MOTION FOR EXTENSION OF TIME TO FILE PRE-FILED REBUTTAL  
TESTIMONY AND EXHIBITS  
ESTABLISHED IN ORDER NO. PSC-2018-0039-PCO-SU**

K W Resort Utilities Corp. (“KWRU”), by and through undersigned counsel, and pursuant to Rule 28-106.204, Florida Administrative Code (F.A.C.), hereby files this Motion for Extension of Time to Respond to Discover, which time to respond is established in Order No. PSC-2018-0039-PCO-SU (“OEP”), issued January 12, 2018 in this docket. KWRU request the granting of this Motion for good cause, and as grounds therefore state the following:

1. On January 12, 2018, this Commission issued the OEP, which provides with regard to pre-filed testimony and exhibits, that “[i]f filing paper copies, an original and 15 copies of all testimony and exhibits shall be filed with the Office of Commission Clerk *by 5:00 pm* on the due date.”
2. KWRU has diligently participated in this Docket by complying with the OEP.
3. While KWRU will be electronically filing testimony, the terms of the OEP do not state whether pre-filed testimony and exhibits electronically filed must be filed by 5:00 pm on the date due. KWRU’s Pre-filed Exhibits and Testimony are due to be filed on the date of this Motion, April 10, 2018.
4. KWRU has been receiving bids and other third party documents up to the date of this Motion, and has not had adequate time to file the pre-filed testimony and exhibits of Christopher Johnson prior to 5:00 pm.

5. In an abundance of caution, KWRU requests a modest two hour and thirty minute extension, to 7:30 pm, April 10, 2018, to file the pre-filed testimony and exhibits of Christopher Johnson.
6. Pursuant to Rule 28-106.204(3), F.A.C., undersigned counsel has attempted to confer with all parties of record and Commission legal staff. OPC does not oppose this motion. Monroe County does not oppose this motion. PSC legal staff takes no position on this motion.

WHEREFORE, KW Resort Utilities Corp. respectfully requests that the Prehearing Officer grant this Motion for Extension of Time to File Pre-filed Testimony and Exhibits in Order No. PSC-2018-0039-PCO-SU, and for such other relief deemed just, equitable, and proper.
