Request for Confidential Classification for Document No. 01676-2018

On February 20, 2018, Florida City Gas (FCG) filed a request for confidential classification for document number 01676-2018. The document contains information relating to a special contract with a customer on the Glades AEP Project, information on capital structure on the Glades AEP Project, and the resulting recalculations of the surcharge. FCG has indicated that the confidential information concerns contractual data with United States Sugar Corporation. Staff reviewed the document and agrees with FCG that the nature of the information meets the requirements set forth in Sections 366.093(3) (d) and (e), Florida Statutes (F.S.), whereby disclosure of the information would harm the competitive business operations of FCG.

Therefore, staff recommends that the request by FCG for confidential classification of the Document No. 01676-2018 be approved.
