I was escorted off the property and I immediately called the fdep the EPA and an investigation and an audit was immediately ordered pluris was found to be guilty of tampering with water not producing samples and many carcinogens in their water they've had nothing but issues over the last couple of years nothing has been solved and all they want to do is raise the rates these people are lying to you these people are on Fair and something needs to be done and it's not a rate hike.
