- 1. How many RDCs did FTRI use in the development of its FY 2017/2018 Outreach Expense projection of \$558,976?

- 2. Staff is estimating 2017/2018 Outreach Expense of \$529,593. FTRI is estimating the full FY 2017/2018 budgeted amount of \$558,976. Does FTRI plan to spend the entire \$558,976 amount budgeted for Outreach in FY 2017/2018?
