- 1. What is the distance in miles between the Four Corners South facility and TECO's existing 69 kV line?
- A. The distance in miles between the Four Corners South facility from Tampa Electric's Fort Green meter station, which will provide electric service to the customer load, is approximately 10 miles. The load will be served over Mosaic's 69kV system located between TEC's Fort Green meter station and the Four Corner's South facility.

- A. In order to provide service to Mosaic, Tampa Electric is rebuilding an existing meter location and performing some 69-kV re-conductor work to support this additional load. Tampa Electric will not be required to extend any service line outside of its territory to provide this service. Mosaic will be responsible for any modifications to its own system to accommodate service across the service territory boundary. Mosaic will build to the Tampa Electric meter station and Tampa Electric will make required terminations.

- A. Tampa Electric is prepared to serve this load longer than May 2019, if the Four Corners South facility is not ready to supply service by that time and if all parties to the agreement agree that Tampa Electric should continue to supply service beyond the projected date.
