On July 18, 2018, Duke Energy Florida, LLC (DEF) filed a request for confidential classification for Document Number 04733-2018. This document is a disc with an Excel spreadsheet that contains information pertaining to employee compensation. The disc—previously submitted as Document Number 03637-2018—was received incident to staff’s first data request. However, DEF later determined that the “Total Hourly Labor Rates” should not be confidential as originally requested. Therefore, DEF amended Document Number 03637-2018, which is to be superseded by Document Number 04733-2018 in the subject docket.

Staff reviewed the amended document and agrees with DEF that the nature of the information meets the requirements set forth in Sections 366.093(3)(d) and (e), Florida Statutes, whereby disclosure of the information would harm the competitive business operations of DEF. Therefore, staff recommends that the request by DEF for confidential classification of Document Number 04733-2018 be approved.
