We recently received one complaint from a customer who contacted the Department two times. The complainant indicated that the Orange Land system (6511307) has been having boil water notices for four months, colored rings forming in toilet, water filter turned brown and growing mold and high chlorine. The complainant indicated that the system owner told her that he forgot to remove the boil water notice from the bill after system maintenance. She also indicated that the water filter was outdoors and her husband was in the process of covering it. I contacted the system operator regarding the complaint. The operator indicated that he had not received any recent complaints. I conducted a site visit on 7/6/2018. The chlorine residual was below 0.2 at that time. I contacted the system operator and his email response:

"Hello Kira,

I made an extra visit to Orangeland today after our phone conversation. The Chlorine residual upon arrival was 0.8 POE and a 0.2 at Knoll. I added 1 gal Cl2 to the barrel and set the Stennar CL2 pump back to its original setting at 70% stroke. The CL2 residual upon leaving was 2.0 POE and 0.7 on Knoll.

The CL2 residual from yesterdays visit was 1.3 POE and 0.7 remote. That is about the average residual carried at this facility. Please let me know if you need anything else. Thank you and have a great weekend.
