INDIAN RIVER COUNTY BOARD OF COUNTY COMMISSIONERS' PETITION TO INTERVENE

The Indian River County Board of County Commissioners (the "Board"), by and through its undersigned counsel, and pursuant to Section 120.54, Florida Statutes, and Rule 28-106.205, Florida Administrative Code, hereby files this Petition to Intervene (the "Petition") in the Florida Public Service Commission (the "Commission") Docket Nos. 20170235-EI and 20170236-EU. In support of its Petition, the Board states as follows:

I. Introduction

II. Entitlement to Participate

- 2. As noted in Order No. PSC-2018-0336-PAA-EU, dated July 2, 2018 (the "Order"), approximately 60 percent of the City of Vero Beach's ("COVB's") 35,000 utility customers reside outside the COVB municipal borders including customers residing in portions of unincorporated Indian River County and portions of the Town of Indian River Shores.
- 3. As the Commission recognized in the Order, for many years, there has been controversy because customers living outside the boundaries of the COVB want to be served by FPL because it charges lower rates than COVB. The customers who live outside COVB have argued that they have no ability to vote for the members of the COVB City Council and thus have no voice concerning the operation or management of the COVB's electric utility and no redress to any governmental authority.
- 4. As explained in the Order, a COVB residential customer who becomes an FPL customer who uses 1,000 kilowatt hours (kWh) would see a bill decrease from \$126.10 to \$99.37, a decrease of \$26.73 or approximately 21.2 percent, based on rates effective March 2018. And COVB commercial and industrial customers would also see bill decreases based on usage.
- 5. As noted in the Order, the dissatisfaction has resulted in years of controversy, repeated efforts to address issues through legislation, multiple filings with the Commission, and litigation between the COVB and the Town of Indian River Shores and Indian River County.

- 6. As the elected representative of all of the citizens of Indian River County, the Board is especially mindful of its role in ensuring that all of its citizens, and especially the citizens served by the COVB in the unincorporated areas of Indian River County, have access to high quality, cost-effective electric service. The health, safety, and welfare of our citizens depend upon this indispensable service, and reliable and affordable electricity is vital to the economic development and well-being of our entire community.
- 7. Additionally, pursuant to section 120.52(13)(d), Florida Statutes, Indian River County has the right to be a party in this proceeding as a county representative representing the interests of the consumers of Indian River County, since the proceeding involves the substantial interests of a significant number of residents of the Indian River County and the Indian River County Board of County Commissioners has adopted several resolutions supporting the sale of the COVB electric utility to FPL, including most recent Resolution 2017-046, expressing support for the current sale proposal. - 8. The Board is also a COVB electric customer, with accounts for many Indian River County facilities including the Indian River County Sheriff's Office, located at 4055 41st Avenue, Vero Beach, FL 32960, the Indian River County Main Library, located at 1600 21st Street, Vero Beach, FL, 32960, and the Indian River County Administration Building, located at 1801 27th Street, Vero Beach, FL, 32960.
- 9. In FY 2016-2017, the Board paid a total of \$1,850,000 in electric bills to the COVB. A 21.2 percent decrease in the electric bill would have resulted in a savings to the Board in FY 2016/2017 of \$392,200.
- 10. The Board supports the preliminary agency action Order No. PSC-2018-0336-PAA-EU, dated July 2, 2018, approving the COVB FPL electric sale as structured.

11. Pursuant to subsection 28-106.204(3), Florida Administrative Code, the undersigned

counsel on behalf of the Board has conferred with all other parties of record and except for

Mr. Moran, no party objects to the petition to intervene. Undersigned counsel has emailed

Mr. Moran on August 22, 2018, August 23, 2018 and August 24, 2018 and have no received

a response as to whether Mr. Moran objects.

III. **Conclusions and Relief**

12. Given the impact to the Board as both a COVB electric customer and as the

representative of both the ratepayers in the COVB and outside of the COVB municipal boundaries,

the Board has demonstrated that it is entitled to intervene and participate in the proceeding.

WHEREFORE, the Indian River County Board of County Commissioners respectfully

requests that the Florida Public Service Commission grant the Petition and uphold the preliminary

agency action Order No. PSC-2018-0336-PAA-EU, dated July 2, 2018.

RESOLUTION NO. 2017- 046

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF INDIAN RIVER COUNTY, FLORIDA, URGING THE CITY COUNCIL OF THE CITY OF VERO BEACH, FLORIDA TO VOTE IN FAVOR OF THE FULL SALE OF THE VERO BEACH ELECTRIC SYSTEM TO FLORIDA POWER & LIGHT COMPANY; DIRECTING COPIES OF THIS RESOLUTION TO BE PROVIDED TO APPROPRIATE PARTIES.

WHEREAS, on November 3, 1981, the Florida Public Service Commission approved a Territorial Agreement between the City of Vero Beach (the "City") and Florida Power & Light ("FPL") which established electric service areas for the City and FPL in Indian River County. Specifically, the electric service area for the City was defined to include the City itself, the Town of Indian River Shores, the south barrier island, and other unincorporated areas of the County, and the service area for FPL was defined to include all other areas of the County; and

WHEREAS, approximately 61% of the City's present customers reside outside the City of Vero Beach. The City has approximately 34,000 total customers, of which approximately 21,000 are non-resident customers. This percentage of non-resident customers (61%) is believed to be the highest percentage of any municipal electric system in Florida; and

WHEREAS, Indian River County, as well as several other taxing bodies such as the Town of Indian River Shores, the Indian River County School Board and the Indian River County Hospital District, are customers of the City electric system and as such pay higher City rates. These increased costs result in higher taxes being imposed on Indian River County taxpayers; and

WHEREAS, FPL has made an offer to buy the entire City of Vero Beach electric utility system for \$185 million; and

WHEREAS, FPL has stated that the \$185 million includes a payment 1) for the cost to exit the Florida Municipal Power Agency (\$108 million); 2) for the cost to exit the power agreement with the Orlando Utilities Commission (\$20 million); 3) for the City's electric utility bonds (\$20.4 million); 4) for a one-time lease payment for the City's substation (\$10 million); 5) for the City's pension liability (\$6.6 million); and 6) of cash (\$20 million); and

WHEREAS, FPL has also offered employment to all qualified City electric system employees; and

WHEREAS, the Board, as the elected representative of all residents of Indian River County, including, those customers of the City's electric utility whose residence or business is located outside of the City limits, has consistently supported the sale of the City's electric utility to FPL, having previously adopted supporting resolutions on several occasions supported the sale by the City to FPL; and

WHEREAS, the people of the City of Vero Beach have on numerous occasions shown that they wish their electric needs be provided with rates comparable to FPL,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF INDIAN RIVER COUNTY, FLORIDA THAT:

- 1. <u>Position of the Board</u>. The Indian River County Board of County Commissioners hereby urges the City Council of the City of Vero Beach to vote in favor of accepting the terms offered by FPL for the full sale of the City of Vero Beach electric utility.
- 2. A certified copy of this resolution shall be provided to the City Council of the City of Vero Beach.
