**SOUTHERN ALLIANCE FOR CLEAN ENERGY'S REQUEST  
FOR ORAL ARGUMENT**

Southern Alliance for Clean Energy ("SACE"), pursuant to Rule 25-22.0022, F.A.C., hereby requests that the Florida Public Service Commission ("Commission") grant oral argument on SACE's Response in Opposition ("Response") to Duke Energy Florida's ("DEF") Petition for Declaratory Statement. The Response has been filed concurrently with this Request for Oral Argument.

SACE is requesting opportunity for oral argument on its Response because oral argument will aid the Commission's deliberations in evaluating the complex issues raised in DEF's petition. As raised in SACE's Response, DEF's petition implicates significant substantive and procedural legal issues, the interpretation of which will substantially impact DEF customers, including SACE members that are DEF customers.
