Dear Clayton-

Every day is an adventure! We are still working on pro forma- It took us a year to get ACF to come and install a compressor for the sand filters. We have had the actual unit for a year- they just couldn't coordinate a time to install. We got no notice or coordination when they did come- they just showed up. The people at Evoqua could never get their act together to give us an actual quote- but we finally got the first of three payments made on the new R/O, so it is on order and due to us by the end of November- we have the installer ready to put it in as soon as it comes- The blowers are installed, just in need of wiring, which is also scheduled. The new decking and safety improvements to the cat walks and tops of the sand filters are being installed now- The system mapping is on back order for over a year, but we are on the list with Florida Rural Water. Can you tell me if there is anything for pro forma that I haven't mentioned?

Also, lightening struck the R/O building and blew out all the wiring and pumps- so we're working on that now. We have replaced two of three lift station panels. The Stuart Avenue lift station has been a non-stop thorn in our side with the 23 homes that it serves managing to rag up our pumps twice a week, blowing all the capacitors each time, to the tune of \$250 a week just for capacitors- we finally got a different type of pump for that lift station, \$9,000. But we only got one of the two. Rats ate the wiring out of the new golf course lift station panel- we have photos of the rat damage less than an hour after a rewired pump was installed... The golf course people, in the heat of their renovation of the golf maintenance area, tore up a water line and also the wiring to the lift station. The sewer plant electrical panel, which the PSC would not give us in pro forma, failed completely and had to be pasted back together until we can afford to completely redo it. All the non-potable pumps failed again and had to be replaced within the last year. Likely a power surge or a lightening strike. We had FPL out to replace the transformer that services the plant- the crew that came refused to touch the transformer because it was in such dangerously bad shape- they had to send a special crew out to change it- We have had the generator completely refitted and repaired- about \$15,000- and we still need to build a new enclosure around it to keep out the rain. We also found out that the original designers of the plant failed to wire the generator to the plant with a proper breaker system and that the 800 amp breaker that we need is over \$10,000, not including installation and wiring. We had the potable water tanks cleaned and inspected. We replaced a bunch of meters. We lost one employee

and hired one full time and one part time. There have been an assortment of breaks and damages that had to be repaired- some under pavement. I guess you could say we've been keeping busy...

Please let us know if there are any pro forma items I did not discuss that need to be addressed. Everything but the mapping will be done by the 1st of December, we hope, and there really isn't anything we can do about the mapping except wait our turn.
