# FLORIDA POWER & LIGHT COMPANY'S NOTICE OF FILING REVISED TARIFF SHEETS IN ACCORDANCE WITH ORDER NO. PSC-2018-0566-FOF-EU

Florida Power & Light Company ("FPL" or "Company") files this Notice of Filing Revised Tariff Sheets in Accordance with Order No. PSC-2018-0566-FOF-EU and states as follows:

On November 30, 2018, the Florida Public Service Commission ("FPSC") entered Order
No. PSC-2018-0566-FOF-EU ("Order 0566") in the above referenced dockets.

2. Order 0566 is the Commission's Final Order Granting the City of Vero Beach and Florida Power & Light Company's Joint Petition to Terminate Territorial Agreement, and Florida Power & Light Company's Petition for Authority to Charge FPL Rates to Former City of Vero Beach Customers and for Approval of FPL's Accounting Treatment for City of Vero Beach Transaction.

3. At page 12 of Order 0566, the Commission directed FPL to file certain revised tariff sheets as follows: "Upon closing of the PSA, FPL shall file revised tariff sheets Nos. 3.020, 3.010, and 7.020 to reflect the addition of the COVB service area to the description of the territory and communities served." The PSA closed on December 17, 2018.

4. Attached hereto and marked as Exhibit A is FPL's Fourth Revised Sheet No. 3.020 which is currently on file with the Commission. Attached hereto and marked as Exhibit B is the revised tariff sheet 3.020 (FPL's Fifth Revised Sheet No. 3.020) which is submitted in accordance with Order 0566. Because the tariff sheet is a high level map of the FPL Service Territory rather than a tariff sheet consisting of text, the revision of tariff sheet No. 3.020 is not susceptible of being provided in legislative and proposed format. The revised tariff sheet No. 3.020 (i.e., FPL's Fifth Revised Sheet No. 3.020) now includes within FPL's service territory the service territory previously served by the City of Vero Beach. FPL notes that in updating tariff sheet No. 3.020 in accordance with Order 0556, the Company has identified additional refinements to the map - unrelated to the COVB territory - that are currently under review and will be identified in a subsequent tariff filing.

5. Attached hereto and marked as Exhibits C and D, respectively, in legislative and proposed format, are FPL's First Revised Sheet No. 3.010 which is the tariff sheet currently on file with the Commission with proposed modifications, and revised tariff sheet 3.010 (FPL's Second Revised Sheet No. 3.010) which is submitted in accordance with Order 0566. The revised tariff sheet No. 3.010 identifies four municipal electric systems operating within FPL's service territory rather than the five municipal electric systems that operated within FPL's service territory prior to the closing of the transaction through which FPL acquired the City of Vero Beach electric utility.

6. Attached hereto and marked as Exhibits E and F respectively, in legislative and proposed format, are FPL's Sixth Revised Sheet No. 7.020 which is the tariff sheet currently on file with the Commission with proposed modifications, and revised tariff sheet 7.020 (FPL's Seventh Revised Sheet No. 7.020) which is submitted in accordance with Order 0566. The revised tariff

sheet No. 7.020 includes the municipalities of Indian River Shores and Vero Beach as communities served by FPL within Indian River County.




