Request for Confidential Classification for Document No. 06352-2018

On October 1, 2018, Florida Power & Light Company (FPL) provided a request for confidential classification for Document No. 06352-2018, which was filed in response to OPC's First Set of Interrogatories No. 5 in the subject docket. This document reflects dollar amounts that are a certain percentage of FPL's forecast of Jurisdictional Operating Revenue for the years 2020 through 2023.

Staff reviewed the document and disagrees with the company that the information is proprietary confidential business information within the meaning of Section 366.093(3), Florida Statutes. FPL provided information for 2023 on page 6 of the petition in the instant docket that allows one to calculate gross annual revenues for 2023. Therefore, staff recommends that the request by FPL for confidential classification of Document No. 06352-2018 be denied.
