DUKE ENERGY FLORIDA LLC'S NOTICE OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION

Duke Energy Florida, LLC (“DEF” or “Company”), pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code (F.A.C.), submits this Notice of Intent to Request for Confidential Classification of confidential portions of DEF’s responses to OPC’s Fourth Set of Interrogatories (Nos. 67-100) and OPC’s Fourth Request for Production (Nos. 18-26). Specifically, the interrogatories, interrogatory answers and attachments relating to questions 67-70, 84, 96, 99 and 100 contain confidential business information. Also, the documents produced in response to OPC’s document requests 19 through 22 contain confidential business information. These interrogatory questions, interrogatory answers, interrogatory attachments, and documents responsive to Request Nos. 19 through 22 contain confidential business information relating to vendor contracts and contractual vendor costs. The disclosure of this confidential information to the public would adversely impact DEF’s competitive business interests and it would impair DEF’s ability to contract for goods and services on favorable terms.

Under a separate cover letter, DEF has filed confidential Exhibit A concerning the above-referenced confidential documents.

Pursuant to Rule 25-22.006(3)(a)1, DEF will file its Request for Confidential Classification for the confidential information contained herein within twenty-one (21) days of filing this request.
