Florida Public Utilities Company's Responses to Staff's First Data Requests

1. What economic development programs does FPUC offer at this time?

FPUC Response:

FPUC's Economic Development program consists of 3 components: Rates & Incentives, Economic Development Assistance, Community Involvement, Education and Leadership.

2. Please explain the details of the economic development programs currently offered by the company.

FPUC Response:

a. Rates & Incentives

FPUC offers a 20% rate reduction in year 1 to attract business, a discount which is reduced by 5% through year 5for qualifying customers in the GS, GSD, and GSLD-1 rate classes. Currently there are no program participants.

b. Economic Development Assistance

Through this component of FPUC's economic development program, FPUC provides technical guidance and informational assistance regarding the availability of gas and electric infrastructure to potential new businesses considering locating, or relocating, to an area within FPUC's service territory. FPUC also conducts projected rate analysis, a review of reliability requirements, as well as assessment of the need for backup generation for new customer prospects.

c. Community Involvement

Under this component of the Company's economic development program, the Company engages in direct community involvement. Through direct employee participation in community economic development boards, business chambers, and working with local governments on economic development strategic planning, the Company gains a more in-depth understanding of the needs of the communities it serves. The Company aids in these economic development activities by sharing information with these local partners, as well as participating in tradeshows, community showcase events, fundraisers, and business outreach designed to encourage economic development. 3. How much economic development money is spent for the company's current economic development programs, how many participants are in each program, how many jobs have been added by these new customers, and what are the annual revenues for each economic development participant customer for 2016, 2017, and 2018 to date?

FPUC Response:

FPUC does not track number of event participants and has no participants in its economic rider program. Annual economic development expenditures for community relations activities include:

a. 2018: \$23,929.00

- b. 2017: \$28,400.05
- c. 2016: \$35,096.75
- 4. What percentage of the company's gross annual income was \$3 million in 1995?

FPUC Response:

According to page 115 of the 1995 FERC Form 1 Annual Report of Major Electric Utilities, Licenses, and Others, FPUC Gross income in 1995 was \$38,369,721. So, \$3 million represents 7.819% of gross income.

5. Please provide the dollar amounts based on gross annual income associated with the following percentages of the company's gross annual revenues:

FPUC Response:

a. 0.175% in 2020:	\$ 1,855,383.92
b. 0.2% in 2021:	\$ 2,162,437.19
e. 0.225% in 2022:	Not Available (Projection data only through 2021)
d. 0.25% in 2023:	Not Available (Projection data only through 2021)

6. For 2016, 2017, and 2018 to date, what is the percentage of shareholder contribution for economic development under the current rule for the company?

FPUC Response:

The percentage of shareholder contribution for economic development is as follows:

- a. 2018: 0%
- b. 2017: 0%
- c. 2016: 0%

7. Please provide the dollar amount of economic development expenses approved in the company's last rate case. Please also include the order number that approved the economic development expense.

FPUC Response:

FPUC proposed the annual Economic Development recovery amount of \$50,000 in Docket 20140025-EI, which was included in the settlement approved in Order No. PSC-14-0517-S-EI.

FPUC Response:
