Dear Mr. Teitzman:

Global Connection Inc. of America (Global or the Company) respectfully submits this filing to notify the Florida Public Service Commission (Commission) of its intention to discontinue provision of wireline local exchange telecommunications services in Florida beginning on April 16, 2019. The effect of this discontinuance upon the Florida competitive telecommunications market will be minimal, as the Company currently provides wireline services to twenty-three or fewer customers in the State and these customers have a number of alternative choices for service providers.

In connection with its decision to discontinue provision of intrastate wireline services in Florida, Global respectfully requests that as soon as practicable after May 14, 2019, the Commission (i) cancel Global's local exchange certificate and price list and (ii) approve the Company's relinquishment of its wireline Eligible Telecommunications Carrier (ETC) designation. In support of this request, Global provides the following information:

Global originally filed this notice and request on March 11, 2019. Pursuant to discussion with Staff, the Company is submitting this amendment to revise the description of Global's designated territory and to include a list of the wire centers which comprise that territory.

I. Discontinuance of Wireline Services: Request for Cancellation of Global's CLEC Certificate and Price List

The Commission granted Global authority to provide competitive intrastate wireline telecommunications services in Florida on June 28, 2001 in Docket No. 010152-TX.² At this time, Global has no more than twenty-three (23) customers in Florida for its wireline services. After extensive assessment of the market, Global has determined that its strategic business plans in Florida do not include the continued provision of wireline telecommunications services.³

Between February 25-27, 2019, Global sent written notice by first-class mail, to all affected customers in Florida, notifying them that the Company will cease providing the prepaid wireline local exchange and interexchange services they currently receive. As a result, these subscribers have received at least forty-five (45) days' notice of the proposed discontinuance. A copy of the notice form sent to Florida subscribers is attached. The notice complies with Federal Communications Commission (FCC) Rule 64.1120(e) and underscores to the subscriber the need to make arrangements with another provider in a timely manner. A toll-free customer service number for the Company is provided so that subscribers may seek assistance from Global personnel while making these arrangements.

Following completion of the discontinuance process, Global does not intend to provide wireline services in Florida. Accordingly, pursuant to Fl. Stat. § 364.335(3), the Company

Global also operates in Florida as a provider of commercial mobile radio services (CMRS) under the d/b/a Stand Up Wireless. This filing solely addresses Global's wireline services. The Company will continue to provide CMRS in Florida.

Global is also discontinuing provision of interstate wireline services to Florida customers and has made the appropriate filing with the Federal Communications Commission. Pursuant to 47 C.F.R. § 63.71(a), the Commission has been served with a copy of the Company's application for discontinuance of interstate wireline service.

Except as explained, below, in n. 4, the discontinuances are scheduled to occur on dates beginning with April 16, 2019 and concluding on May 13, 2019. The Company intends to time the discontinuances to align with the end of each customer's prepaid monthly service period. Each customer has been sent a notice identifying the specific date on which his or her discontinuance is scheduled.

Three of the Company's wireline services customers receive federal Lifeline discounts in connection with Global's service. Pursuant to discussion with Commission Staff, these customers' services will not be discontinued until the matter of Global's ETC relinquishment is resolved.

respectfully requests that the Commission cancel its wireline authority and associated price list on or after May 14, 2019.⁶

II. Relinquishment of ETC Designation

The Commission designated Global as an ETC for provision of wireline low-income (Lifeline-supported) services in certain BellSouth Telecommunications, Inc. d/b/a AT&T Florida exchanges on September 15, 2011 in Docket No. 20090514-TX. In connection with its exit from the wireline sector, Global respectfully requests to relinquish its designation. The Communications Act of 1934, as amended, and FCC Rule 54.205 provide that an ETC designated in an area served by more than one ETC shall be permitted to relinquish its designation. At this time, the Company believes that there are a number of other ETCs serving within Global's designated area, including Frontier, Windstream, CenturyLink Embarq, Knology, SafeLink Wireless, Assurance Wireless, T-Mobile and other wireless ETCs. Accordingly, Global's request to relinquish its designation should be approved.
