Duke Energy Florida, LLC (“DEF” or the “Company”), pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code (F.A.C.), submits this Notice of Intent to Request Confidential Classification of documents provided in DEF’s Response to the Office of Public Counsel’s (“OPC”) Second Request to Produce (Nos. 26-29) filed contemporaneously with this notice.
