By this letter, Commission staff requests that Peninsula Pipeline Company (Peninsula) and Florida Public Utilities Company (FPUC) provide responses to the following data requests:

- 1. Staff noticed minor discrepancies between attachments A and B to the petition and the petition itself regarding the locations and descriptions of certain interconnects. Please confirm that the third sentence of paragraph 10 of the petition should list North Lake/Northlake Boulevard rather than Seminole Pratt Whitney Road.
- 2. Please confirm that Peninsula would construct a new interconnection with Florida City Gas at the northeast intersection of US Highway 98/State Road 80 and Seminole Pratt Whitney Road.
- 3. Referring to page 10 of the Agreement, please define PPC and confirm if this is the same as the Florida Southeast Connector.
- 4. Please briefly describe the nature of service and the customer base already being served by FPUC in the Palm Beach County area. Are these existing customers included in the approximately 10,000 referred to in FPUC's response to Staff's First Data Request, #9?
- 5. Which pipelines does FPUC currently use to transport gas to the Palm Beach County area?
- 6. Please state the expected in-service date that begins the initial period of 20 years.
