Joint Responses of Peninsula and FPUC to Staff's Second Data Requests

1. Staff noticed minor discrepancies between attachments A and B to the petition and the petition itself regarding the locations and descriptions of certain interconnects. Please confirm that the third sentence of paragraph 10 of the petition should list North Lake/Northlake Boulevard rather than Seminole Pratt Whitney Road.

Company Response: Yes, Seminole Pratt Whitney Road should be Northlake Boulevard.

2. Please confirm that Peninsula would construct a new interconnection with Florida City Gas at the northeast intersection of US Highway 98/State Road 80 and Seminole Pratt Whitney Road.

Company Response: The newly proposed interconnection with Florida City Gas at the northeast intersection of US Highway 98/State Road 80 and Seminole Pratt Whitney Road will be constructed by Florida City Gas. Peninsula proposes constructing the pipelines that extend west and north from that interconnection to the developments of Arden and Westlake respectively.

3. Referring to page 10 of the Agreement, please define PPC and confirm if this is the same as the Florida Southeast Connector.

Company Response: PPC is Peninsula Pipeline Company and is not the same as the Florida Southeast Connection.

4. Please briefly describe the nature of service and the customer base already being served by FPUC in the Palm Beach County area. Are these existing customers included in the approximately 10,000 referred to in FPUC's response to Staff's First Data Request, #9?

Company Response: The Seventh Revised Sheet No. 6 of FPUC's tariff lists the communities currently served in Palm Beach County. The types of service include residential and commercial service and lighting. The customers referred to in response to Staff's First Data Request #9 are customers that are being added as a result of this proposed project.

5. Which pipelines does FPUC currently use to transport gas to the Palm Beach

County area?

Company Response: Currently FPUC transports gas on the Florida Gas Transmission's interstate pipeline. As a result of this request, FPUC would also transport on the Florida Southeast Connection intrastate pipelines, as well as on the Florida City Gas pipeline.

6. Please state the expected in-service date that begins the initial period of 20 years.

Company Response: The expected in-service date is January 2020.
