Pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code, Gulf Power Company (GPC) requests confidential classification of certain information filed in response to an Office of Public Counsel (OPC) Production of Documents (POD), in the above referenced docket, dated August 12, 2019. This recommendation specifically addresses the separate DVD bearing the label "CONFIDENTIAL", produced by GPC in response to OPC's First POD, Nos. 1 and 5.

GPC is claiming confidentiality of the entire DVD produced in response to OPC's First POD, Nos. 1 and 5, under Section 366.093(3)(d) and Section 366.093(3)(e), F.S. Per the Statute, propriety or confidential business information includes, but is not limited to; Subsection (d) "[i]nformation concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms" and Subsection (e) "[i]nformation relating to competitive interests, the disclosure of which would impair the competitive business of the provider of information."

The information provided in response to OPC's First POD, Nos. 1 and 5, for which confidential treatment is being sought, can be described as company-specific avoided costs relating to fuel, generation, transmission, and distribution and information regarding payments made pursuant to a contract with GPC's vendor for technical services associated with the 2020 FEECA Goalsetting process.

Staff has reviewed the information GPC filed in response to OPC's First POD, Nos. 1 and 5, as well as the Company's confidentiality request. It is staff's opinion that the information that is the subject of this request meets the criteria for confidentiality contained in Section 366.093(3)(d)

and Section 366.093(3)(e), F.S., as applies to the separate DVD bearing the label "CONFIDENTIAL", provided in response to OPC's First POD, Nos. 1 and 5.
