- 2. Please explain why FPL and Okefenoke negotiated two documents: an Amendment of Territorial Agreement and a Memorandum of Understanding.
- 3. The Memorandum of Understanding contains a provision which requires FPL, provided final Commission approval of the territorial agreement, to construct certain distribution facilities for the benefit of Okefenoke and to transfer such facilities for \$10. Please explain how FPL will recover the cost of constructing those distribution facilities and what the basis is for the \$10 cost of those facilities to Okefenoke. What are the estimated costs FPL will incur to construct the Okefenoke distribution facilities?
