Attached for filing is an errata sheet correcting Exhibit JE-7 of the rebuttal testimony of Florida Power & Light Company witness Juan Enjamio, which was originally filed on September 23, 2019. An amended version of Exhibit JE-7 is also attached. The total CPVRR calculation of \$249 million in this amended exhibit remains unchanged from the original exhibit.
