2	COMMISSIONER CLARK: All right. We are we are
3	going to go ahead and call this prehearing to
4	order.
5	Y'all bear with me a little bit this morning.
6	I had a root canal yesterday afternoon. I am
7	hoping y'all are going to make this less painful
8	than that was yesterday, right? So pardon me if I
9	get a little choked up and drink a lot of water
10	here today.
11	All right. Let's I request that staff go
12	ahead and read the notice, please.
13	MR. SCHRADER: Yes, sir.
14	By notice issued on October 9th, 2019, this
15	time and place has been set for prehearing
16	conferences in Docket Nos. 20190001-EI,
17	20190002-EG, 20190003-GU, 20190004-GU and
18	20190007-EI. The purpose of these prehearings are
19	set out more fully in the notice.
20	COMMISSIONER CLARK: All right. Thank you
21	very much.
22	We are going to go ahead and take appearances,
23	and the second time we are just going to take
24	appearances in all of the dockets. If you would,
25	please state which docket you will be appearing in

1	and we will start with FPL and go all the way
2	through staff.
3	MS. MONCADA: Good morning, Commissioner.
4	Maria Moncada for Florida Power & Light Company,
5	appearing in the 01, 02 and 07 dockets. I would
6	also like to enter appearance for General Counsel,
7	Wade Litchfield in the same dockets.
8	In the 01 and 07 docket, I would like to also
9	enter an appearance for David Lee. And in the 02
10	docket, for Joel Baker.
11	Thank you.
12	COMMISSIONER CLARK: Thank you.
13	MR. BERNIER: Good morning, Commissioner.
14	Matt Bernier for Duke Energy. I am entering an
15	appearance in the 01, 02 and 07 dockets. And I
16	would also like to enter an appearance for Dianne
17	Triplett in the same dockets.
18	Thank you.
19	MR. BADDERS: Good morning, Commissioner
20	Clark. Russell Badders on behalf Gulf Power
21	Company in the 01, 02 and 07 dockets. I would also
22	like to enter an appearance for Steven Griffin of
23	the law firm of Beggs & Lane in the same dockets.

23	COMMISSIONER CLARK: Thank you.
24	MR. MARSHALL: Good morning. Bradley Marshall
25	with Earthjustice representing the Sierra Club in

1	the 07 docket. I would also like to put in an
2	appearance for Diana Csank.
3	MS. WYNN: Good morning, Commissioner. Laura
4	Wynn on behalf of White Springs Agricultural
5	Chemicals, PCS Phosphate in the 01, 02 and 07
6	dockets. I would also like to enter an appearance
7	for my partner Jay Brew.
8	MR. REHWINKEL: Good afternoon, Commissioner.
9	Charles Rehwinkel with the Office of Public
10	Counsel. I am appearing in all dockets. I would
11	also like to enter an appearance for Patty
12	Christensen, Thomas, Tad, David, Stephanie Morse
13	and J.R. Kelly. Their appearances are as noted in
14	the draft prehearing orders.
15	COMMISSIONER CLARK: Thank you.
16	MR. REHWINKEL: Thank you.
17	MR. SCHRADER: For staff in the 03 docket, we
18	have myself, Kurt Schrader. In the 04 docket, we
19	have Rachael Dziechciarz. In the 02 docket, we
20	have Margo DuVal and Gabriella Passidomo. In the
21	07 docket, it will be Charles Murphy and Ashley
22	Weisenfeld. And in the 01 docket, Suzanne
23	Brownless.
24	MS. HELTON: And finally, I am here as your
25	advisor, Mary Anne Helton. I would also like to

1	make an appearance for your General Counsel, Keith
2	Hetrick.
3	COMMISSIONER CLARK: All right. Thank you.
4	Anybody else? Did everybody get to speak?
5	Okay. We will move into the order of the
6	dockets. We are going to take these up a little
7	differently today, not necessarily in numerical
8	order. We are going to take them up in the 03, the
9	04, 02, the 07 and then the 01 dockets. Everybody
10	good with that?
11	All right. If there are no questions or
12	issues, we will move immediately into the 03
13	docket.
14	Mr. Schrader, let's begin with preliminary
15	matters.
16	MR. SCHRADER: Yes, Commissioner.
17	Staff will note for the record that St. Joe
18	Natural Gas Company has been excused from the
19	prehearing in the 03 docket, and there are no other
20	preliminary matters that staff is aware of.
21	COMMISSIONER CLARK: All right. Anybody else
22	have any preliminaries?
23	All right. Let's run through the draft
24	prehearing order. We will go through each of the
25	sections. I am just going to just call them out

1	quickly. If anybody has any problems, let me know,
2	we will stop and slow down when we get the
3	positions.
4	Case background.
5	Conduct of proceedings.
6	Jurisdiction.
7	Procedure for handling confidential
8	information.
9	Prefiled testimony.
10	Order of witnesses.
11	MR. SCHRADER: Staff is hopeful that all
12	issues with the parties can be stipulated and
13	witnesses excused in this docket. Staff will
14	continue to work towards this end.
15	COMMISSIONER CLARK: Anyone else?
16	All right. Basic positions. Nobody changed
17	their mind.
18	All right. Issues and positions.
19	MR. SCHRADER: Staff notes that the order
20	establishing procedure requires that a party take a
21	position at the prehearing conference unless good
22	cause is shown as to why that party cannot take a
23	position at this time.
24	Accordingly, if a party's position in the
25	prehearing order is currently no position at this

1	time, that party must change its position or show
2	good cause why it cannot take a position.
3	Staff will also suggest that parties who have
4	not yet take a position, or wish to change their
5	position, be allowed to submit their position in
6	writing no later than close of business tomorrow,
7	Wednesday, October 23rd. If a party fails to take
8	a position by that time, the prehearing order will
9	reflect no position for that party for such issues.
10	COMMISSIONER CLARK: All right. Let's move
11	into the exhibit list.
12	MR. SCHRADER: Staff will note that have
13	prepared and circulated to the parties a draft
14	comprehensive exhibit list which includes all
15	prefiled exhibits. Staff will check with the
16	parties prior to the hearing to determine if there
17	are any objections to the comprehensive exhibit
18	list.
19	COMMISSIONER CLARK: All right. Any
20	questions?
21	All right. Proposed stipulations.
22	MR. SCHRADER: There are none at this time,
23	Commissioner.
24	COMMISSIONER CLARK: Pending motions.
25	MR. SCHRADER: None at this time,

1	Commissioner.
2	COMMISSIONER CLARK: Pending confidentiality
3	motions.
4	MR. SCHRADER: No, Commissioner.
5	COMMISSIONER CLARK: All right. Post-hearing
6	procedures.
7	MR. SCHRADER: If the issues are stipulated
8	and the parties agree to waive briefs, the
9	Commission may make a bench decision for this
10	position for this portion of the docket. If
11	there are any issues to be briefed, staff
12	recommends that post-hearing briefs be no longer
13	than 40 pages.
14	COMMISSIONER CLARK: All right. Are all
15	parties in agreement?
16	Mr. Rehwinkel.
17	MR. REHWINKEL: Yes. Commissioner, I just
18	wanted to note for the record and for staff's
19	benefit, our position on all issues is no position
20	at this time. It it can be changed to no
21	position.
22	COMMISSIONER CLARK: Okay.
23	MR. REHWINKEL: We will not be submitting any.
24	COMMISSIONER CLARK: Okay. Thank you very
25	much.

2	All right. Rulings.
3	MR. SCHRADER: Staff would note any briefs
4	will be due on November 15th, 2019. Staff will
5	note that St. Joe Natural Gas Company's excusal
6	from the prehearing in this docket will be included
7	in the prehearing order.
8	COMMISSIONER CLARK: All right. Opening
9	statements are going to be limited to five minutes
10	unless the parties choose to waive those opening
11	statements, and summaries are going to be limited
12	to three minutes and briefings to 40 pages.
13	Are there any other matters that we need to
14	address in this prehearing conference?
15	MR. SCHRADER: Staff is aware of none,
16	Commissioner.
17	COMMISSIONER CLARK: Anyone else?
18	All right. We will adjourn the 04 docket
19	and we will adjourn the 03 docket and move into
20	the 04 docket.
