October 5, 2019 - Memory recall of telephone conversation with FP&L

### lanuary 18, 2019 -

Mr. Richard Claudio from FP&L net metering called and left a voicemail (see audio file) stating our system was too large.

I called him back and he told me the system size was too large and we had to reduce the size. I told him the system was already installed and, as far as I knew, our project was at the point where FP&L needed to just come switch out our meter for a net metering one and we were done and can start using our panels. I told him this was the first I had been told by anyone that our system was too large. He said that the FP&L website states the sizing requirements for residential solar systems and, based on our yearly consumption, the system was too large. I explained that we were in the process of building a large pool (heated and cooled), adding a hot tub and expanding our outdoor living space with more lighting and that is why our contractor recommended this size. He said that they base sizing on the past 12 months of electrical usage and don't take into consideration future use so we still had to reduce the size. I basically told him that didn't make sense to me and I wanted to speak with his supervisor.


He put me on the phone with Kaz Melians, who basically repeated what Mr Claudo told me and, again, I told him this was the first I was hearing about this. He then told me we should have been pre-approved by our contractor. I told him I didn't know anything about that because Mr. Da Veiga applied on my behalf over the internet via my FP&L account. He then told me that I shouldn't have allowed him to do that and he should have gone in as a contractor and then started questioning Mr. Da Veiga's motives and credentials and going off in that direction. I told him I didn't know about all that and that this was all permitted and after going back and forth for a bit he started to get a little annoyed with me and stated that they may have to require us to provide documentation and plans to prove we were doing the construction I had mentioned. I said that was fine and he said they would take into consideration our conversation and get back to me.


After the January 18 telephone conversation, I contacted Gabriel Da Veiga and told him what I was told by Mr. Claudio and Mr. Melianz.




From there on, all communications with FP&L concerning our case have been through Mr. Da Veiga and Mr. Kyle Egger.


