Rachael,

Sebring agrees to Staff's request for an extension of the waiver previously provided by the Company to allow Staff to now take its recommendation on Sebring's rate request to the January 7 Agenda conference. I should note that this further delay will result in Sebring's inability to recoup approximately \$25,170 of its incremental annual revenue requirement for 2020, which is its projected test year, and perhaps more, given that the Company typically sees its highest system usage during January.

As such, the Company asks that consideration be given to allowing the Company to implement the rate increase for billings on meter readings taken 20 days following the Commission's vote (January 27), rather than 30 days.
