SETTLEMENT AGREEMENT

THIS SETTLEMENT AGREEMENT ("Agreement") is made and entered as of the day of DECEMBER, 2019 ("Effective Date"), by and between GTT Communications, Inc., formerly known as Global Telecom and Technology, Inc. ("GTT"), David J. Smat ("Smat"), Innovative Government Telecom Solutions, Inc. ("Innovative"), iNetworks Group, Inc. ("Group") and iNetworks Services LLC ("Services," and collectively, with Innovative and Group, the "Companies"). GTT and Smat may sometimes be referred to as the "Parties."

RECITALS:

- A. WHEREAS, on March 28, 2013, GTT entered into a Sales Novation and Transfer Agreement with Group and Innovative whereby Group and Innovative sold and transferred certain assets and accounts to GTT; and
- B. WHEREAS, on November 30, 2013, GTT, Innovative and Group entered into a Second Sales Novation and Transfer Agreement whereby Group and Innovative sold and transferred certain assets and accounts to GTT; and
- C. WHEREAS, GTT paid Innovative and Group a total of \$4,042,696.00 as consideration for these transfers; and
- D. WHEREAS, subsequent to the execution of the above agreement and GTT's payment therefore, Innovative and Group received payments for the transferred accounts which they had agreed to hold in trust for and remit to GTT as soon as practicable; and
- E. WHEREAS, as of March 8, 2016, Innovative and Group were indebted to GTT for sums received but not remitted in the amount of \$2,744,557.00; and
- F. WHEREAS, as of December 30, 2016, Innovative and Group's debt to GTT had grown to \$3,088,789.50; and
- G. WHEREAS, on December 30, 2016, the Companies executed a Promissory Note to GTT in the amount of \$3,088,789.50 for the above obligation; and
 - WHEREAS, the Companies suspended operations on or about July 15, 2017; and
- WHEREAS, on or about January 10, 2018, GTT obtained a judgment in the amount of \$3,088,789.50 against the Companies in the Circuit Court of Cook County, Illinois at No. 2017-L-010432 (the "Judgment"); and
- J. WHEREAS, Smat currently owns and has owned 100% or a majority of the interests in each Company since their creation and currently is the President or Chief Executive Officer of these entities; and

- K. WHEREAS, Smat filed a petition for personal bankruptcy under Chapter 7 of the Bankruptcy Code on August 11, 2017 at case No. 17-bk-24063 in the United States Bankruptcy Court for the Northern District of Illinois (the "Bankruptcy Court"); and
- WHEREAS, on October 26, 2017, GTT filed a proof of claim in Smat's bankruptcy case in the amount of \$3,163,313.50, asserting that he was personally liable to GTT for the abovereferenced obligations; and
- M. WHEREAS, on October 31, 2017, GTT filed a timely Complaint to except its claim from discharge in Smat's personal bankruptcy case under 11 U.S.C. §523 and also to deny a general discharge of debts under 11 U.S.C. §727 at Adversary Proceeding No. 17-ap-0547 (which Complaint was amended on February 7, 2018) (the "Lawsuit"); and
- WHEREAS, Smat filed an Answer in the Lawsuit denying all personal liability for the debt; and
- WHEREAS, GTT and Smat have had a full opportunity to take discovery relating to the allegations and defenses of the Complaint and to avail themselves of the benefit of legal advice relating to this action and, its potential risks and costs, and have done so to their sati sfaction:
- WHEREAS, by virtue of this Agreement, the Parties desire to settle any and all claims, defenses, and/or counterclaims that were asserted in the Lawsuit and in the bankruptcy case and to provide a mechanism for the repayment of the Judgment by Innovative, and to collect from Smat the principal sum of \$500,000.
- NOW, THEREFORE, in consideration of the promises and the mutual covenants of the Parties stated in this Agreement, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:
- Recitations. The above recitations are true and correct and are incorporated herein by this reference.
- Non-Admission of Liability. No judgment has been rendered in the Lawsuit. Nothing in this Agreement shall constitute or be construed as an admission of liability or an admission as to the validity of any allegations or defenses made within the Lawsuit, by or on behalf of the Parties, or their respective, agents, affiliates, assigns, parents, successors, subsidiaries, and/or successors.
- Payment. Upon the Effective Date, Smat will execute the Promissory Note attached as Exhibit A hereto and make the first payment as identified therein. The terms of the Promissory Note are incorporated by reference as if fully set out herein and are part of the consideration for this Agreement.
- Dismissal Without Prejudice. Within ten (10) days after the execution of this Agreement and the Promissory Note, and payment of the first Settlement Payment due under the Promissory Note is received by GTT's counsel (or within such time required by the rules of Bankruptcy Court) GTT will take action with the Bankruptcy Court to dismiss the Lawsuit without

prejudice. Smat and the Companies acknowledge that, notwithstanding this Settlement with GTT. other creditors may have the rights under 11 U.S.C. §727, subject to such terms as the Bankruptcy Court may set.

- Mutual Release. Except as set out herein and preserved by this Agreement and the Promissory Note.
- GTT hereby remises, releases, acquits and forever discharges Smat, his immediate family members, heirs, and the successors and assigns of his personal assets (collectively, the "Smat Parties") from of and from all manner of action and actions, cause and causes of action, suits, debts, dues, sums of money, accounts, reckonings, bonds, bills, specialties, covenants, charges, contracts, controversies, agreements, promises, variances, trespasses, damages, judgments, executions, claims, and demands whatsoever, in law or in equity, which were raised in, arise out of, relate to, or in any way directly or indirectly, involve the Lawsuit or the events described in the Lawsuit which the GTT Parties (as defined herein) ever had, now has or may have from March 28, 2013 to the Effective Date. This release, however, shall not extend to. extinguish or limit (i) Smat's liability under the Promissory Note executed in connection herewith. or (ii) Smat and the Companies' obligations under this Agreement.
- b. Smat hereby remises, releases, acquits and forever discharges GTT, its past. present and future officers, directors, heirs, agents, servants, employees, legal representatives. assigns, successors, affiliates, shareholders, beneficiaries, predecessors, insurers, administrators, and successors-in-interest; parent and holding companies, subsidiaries, affiliated and related entities; any business entities or divisions owning or controlling GTT in whole or in part; and any business entities or divisions owned or controlled in whole or in part by GTT (collectively the "GTT Parties"), of and from all manner of action and actions, cause and causes of action, suits, debts, dues, sums of money, accounts, reckonings, bonds, bills, specialties, covenants, charges, contracts, controversies, agreements, promises, variances, trespasses, damages, judgments, executions, claims, and demands whatsoever, in law or in equity, which were raised in, arise out of, relate to, or in any way directly or indirectly, involve the Lawsuit or the events described in the Lawsuit which the Smat Parties ever had, now has or may have, or which any Smat Party hereafter can, shall, or may have against any of the GTT Parties, from March 28, 2013 to the Effective Date. This release, however, shall not extend to, extinguish or limit GTT's obligations under this Agreement.
- Confidentiality of Financial Information Provided by Smat and Innovative. GTT will use its commercially reasonable efforts to keep any financial information provided to it by Smat and/or Innovative pursuant to paragraph 6 of the Promissory Note, and which is marked "CONFIDENTIAL, SUBJECT TO SETTLEMENT AGREEMENT" confidential and it shall be disclosed only 1) as necessary to third parties who may be assisting in determining the proper payment amounts due to GTT; 2) in any action to prove an Event of Default (as that term is used in the Note); or 3) as required by law or order of a court of competent jurisdiction; subject to Smat and/or the Companies being provided at least 10 days prior written notice to contest any requirement to produce such documents. Any violation or alleged violation of this paragraph shall not excuse Smat or the Companies from their obligations under this Agreement or the Promissory Note.

- 7. Action Against the Companies. Except as set out herein, nothing in this Agreement shall constitute a release of the Judgment or any claims or judgments heretofore or hereafter acquired by GTT against any other third party (other than the Smat Parties) who has acquired possession or use of property or assets of the Companies without consideration or in fraud of creditors (the "Third Party Litigation").
- a. GTT and the Companies agree that the principal amount of the Judgment shall be capped at \$3.2 million, and interest will not run on that amount so long as no Event of Default has occurred under the Promissory Note. The Judgment will be marked satisfied upon payment of the full \$3.2 million amount. For the avoidance of doubt, any collections resulting from the Third Party Litigation shall be applied against the \$3.2 million.
- b. GTT acknowledges that Smat's personal payment obligations are limited to as set forth in the Promissory Note and that he shall not be obligated to and shall have the sole discretion as to whether to cause Innovative to recommence its operations. In the event that Innovative re-commences and continues operations, Innovative agrees to pay GTT 7% of its collected cash-based revenues on a monthly basis until the Judgment is satisfied. Payments made by Innovative, if any, will be applied as set forth in the Promissory Note, and thereafter shall be applied to the Judgment until satisfied.
- c. Innovative grants GTT a security interest in its equipment, fixtures, inventory, accounts, chattel paper, instruments, general intangibles, letters of credit rights and deposit accounts to secure Innovative's and Smat's obligations hereunder and authorizes GTT to file one or more financing statements to perfect its interest.
- d. Moratorium on Collection Against the Companies. GTT agrees that, for so long as no Event of Default has occurred under the Promissory Note, it will not take any action to execute on the Judgment and no interest will run on the Judgment. Notwithstanding the foregoing, GTT may transfer the Judgment to other jurisdictions and may pursue recovery of voluntary or involuntary transfers of assets from any of the Companies to third parties other than the Smat Parties that were made without consideration or in fraud of creditors prior to the date of this Agreement
- 8. Entire Agreement. This Agreement and the Promissory Note constitutes the sole and entire agreement between the Parties and supersedes all prior and contemporaneous statements, promises, understandings or agreements, whether written or oral.
- 9. <u>Amendments</u>. This Agreement may be amended, modified or altered at any time upon the approval of the Parties; however, any such amendment must be in writing and signed by all Parties in order for such amendment to be of any force and effect.
- 10. Partial Invalidity. In the event that any provision of this Agreement is declared by any court of competent jurisdiction or any administrative judge to be void or otherwise invalid.

all of the other terms, conditions and provisions of this Agreement shall remain in full force and effect to the same extent as if that part declared void or invalid had never been incorporated in the Agreement and in such form, and the remainder of the Agreement shall continue to be binding upon the Parties.

- 11. Survival. All representations, obligations and warranties contained herein shall survive the execution and delivery of this Agreement, and the execution and delivery of any other document or instrument referred to herein. Execution of this Settlement Agreement does not release any obligations under the Promissory Note, which also survive execution and delivery of this Agreement.
- 12. Applicable Law. This Agreement shall be subject to and governed by the laws Illinois, without regard to conflict of law rules. The Parties hereby consent to jurisdiction in the state or federal courts of Illinois for any action arising out of, under or in connection with this Agreement.
- 13. No Confidentiality. The Parties acknowledge that the terms of this Agreement and Promissory Note may be filed with the Bankruptcy Court and heard in open court and will become part of the public record. In addition, the terms of this Agreement and the Promissory Note may be filed in state or federal court in an action to enforce this Agreement or the Promissory Note.
- 14. Cross Default. Breach of the Promissory Note is a breach of all parts of this Agreement.
- 15. <u>Attorney Representation</u>. The Parties acknowledge and agree that they are under no duress or undue influence and that they are entering into this Agreement voluntarily. Prior to and in connection with the execution of this Agreement, each Party had the opportunity to consult with legal counsel of its own selection and had adequate opportunity to review this Agreement.
- 16. No Adverse Construction. The Parties acknowledge that this Agreement has been prepared by each of them. In the event any part of this Agreement is found to be ambiguous, such ambiguity shall not be construed against any Party.
- 17. <u>Authority</u>. Each person(s) executing this Agreement as an agent or in a representative capacity warrants that he or she is duly authorized to do so on behalf of the Party he or she represents.
