1. Please provide a detailed description of why the requested storage trailer is needed.

Company Response: Because these utilities have no plant, I do not have a place to store parts and equipment needed for repairs. Given the distance between the utility office and Heather Hills and Sunny Shores Utilities, the storage trailer is needed for storage of repair parts, fittings, a mud pump and pipe that is needed to make any emergency or non-emergency repairs. I originally was going to rent a local storage unit and got prices around the \$200 per month range. Instead of having an ongoing cost to the customers for the storage unit, I thought it would be more cost effective for the customers for me to buy the used storage trailer. I have permission from Sunny Shores to keep the trailer on site. This approach will greatly cut down on utility response time to any repairs that may be needed. (Seems like we always have a water line break the early morning hours or weekends and holidays when the local plumbing parts store is not open??)

2. Please provide all bids that the Utility received for storage trailers. If only one bid was obtained, please explain why.

Company response: In an effort to be cost conscience, the utility did not get any bids for a new trailer, but purchased a used 2013 trailer.

3. Please provide the invoice for the purchased storage trailer.

Company Response: Please see enclosed redacted copy of the trailer title, bill of sale, copy of the banks statement and check issued to the seller and the tag/ transfer costs.

4. Please provide a detailed description of why the requested van is needed.

Company response: The van is needed for the new field technician approved by the Commission in the West Lakeland docket.

5. If approved, which employee(s) would the van be assigned to?

Company Response: The employee that the van will be assigned to has not been hired yet. I am awaiting the conclusion of the protest period of the West Lakeland Docket and the issuance of the commission's final order. I need to buy the van first and then hire the person.



**IMPORTANT INFORMATION**

Section 316.613, Florida Statutes, requires every operator of a motor vehicle transporting a child in a passenger car, van, autocycle or pickup truck registered in this state and operated on the highways of this state, shall, if the child is 5 years of age or younger, provide the protection of the child by properly using a crash-tested, federally approved child restraint device. For children aged through 3 years, such restraint device must be a separate carrier or a vehicle manufacturer's integrated child seat. For children aged 4 through 5 years, a separate carrier, an integrated child seat, or a child booster seat may be used. For limited exceptions, see s. 316.613, F.S.

S. 320.02 and 627.733, F.S., requires personal injury protection and property damage liability to be continuously maintained throughout the registration period. Failure to maintain the mandatory coverage may result in the suspension of your driver license and registration.

Important note: If you cancel the insurance for this vehicle, immediately return the license plate from this registration to a Florida driver license or tax collector office or mail it to: DHSMV, Return Tags, 2900 Apalachee Parkway, Tallahassee, FL 32399. Surrendering the plate will prevent your driving privilege from being suspended.
