GENERAL SUBJECT MATTER TO BE CONSIDERED: Docket No. 20200001-EI, *In re: Fuel and purchased power cost recovery clause with generating performance incentive factor*; Docket No. 20200002-EG, *In re: Energy conservation cost recovery clause*; and Docket No. 20200007-EI, *In re: Environmental cost recovery clause*.

The purpose of this workshop is to discuss modifications to Order No. PSC-2012-0425-PAA-EI to comply with Internal Revenue Code Treasury Regulation Section §1.167(1)-1(h)(6), specifically the methodology for calculating the weighted average cost of capital (WACC) applicable to clause-related investments.
