Currently the rates and charges for Wastewater Service are regulated by the Florida Public Service Commission (FPSC).

Water Oak has informed the FPSC, that it will begin to receive bulk wastewater service from the Town of Lady Lake, and is requesting to cancel Certificate No. 388-S. The Utility will be charging customers a rate which does not exceed the actual purchase price of the bulk wastewater service. This will make the wastewater system except from regulation by the FPSC under the provisions of Section 367.022(8) of the Florida Statutes. The water system will continue to be regulated by the FPSC.


The Commission intends to consider the matter at the March 3, 2020, Agenda Conference.
