1 PROCEEDINGS 2 CHAIRMAN CLARK: Good morning. It is 9:30. 3 We are going to begin Agenda Conference this 4 morning. I would like to welcome everyone who is 5 here with us live and those that are joining us remotely. We have quite an extensive agenda today, 6 7 so we are going to go ahead and get started.
