This letter is to request that the Florida Public Service Commission (Commission) notify the Universal Service Administrative Company (USAC) and the Federal Communications Commission (FCC) pursuant to 47 C.F.R. §54.314 that Embarq Florida, Inc. d/b/a CenturyLink ('Company') is eligible to receive federal high-cost (Connect America Fund) support.
