Hi Margo,

Can you please give me a call? I have entered your request to establish docket. I note that rule dockets usually do not have parties of record, but your req indicates that only OPC is an interested person and everyone else is a party of record. I need to confirm that all of the ones that you have entered in the parties section of the req are to actually be designated in CMS as "parties of record." The utilities in the docket determine the suffix of the docket. I initially gave it an EI suffix because the rule is related to electric utilities and you indicate that it relates to all investor-owned electric utilities. However, I think it should be changed to PU (public utility - general), since your parties include both electric (EI and EM) and gas (GU) entities. Just need to get a little more information.
