Complaint: Improper Billing against Utilities, Inc. of Florida

Details:

Per Docket 20200139-WS, Utilities Inc. is asking for an additional rate increase again. This amounts to almost a 90% increase in rates over a four year period. When the corporate parent of Utilities Inc. purchased most of the local water providers in FL and consolidated, they did a massive rate increase of nearly 70% but noted to the Public and the PSC that this would be a one time increase and would negate the need for future increases for quite awhile as this would revenue neutralize the rates across the state for the now common owner. However, this is now the fifth rate increase over that same four year period that are requesting the PSC approve.

Per State Law, utility companies are supposed to show that their profit margin is below 13%. However, last year (2019) Utilities Inc. has a profit of \$8.9 Million which is approximately a 24% profit margin. Since their profit margin is that high, shouldn't the rate we're forced to pay be lower (or at least stay the same) rather than increase again? They are nearing double the profitability margin in the statutory formula.
